ORDER

WHEREAS, the recognition was granted to the institution namely A.M. Reddy College of Education, Petlurivari Palem, Narasaraopet Mandal, Guntur – 522601, Andhra Pradesh run by Atluri Masthan Educational Society, Guntur, Andhra Pradesh vide SRC (NCTE) order no. F.SRO/NCTE/APS07104/B.Ed/2006-2007/3330 dt. 26.05.2007 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

2. AND WHEREAS, the SRC in its 166th meeting held on 18th-19th October, 2008. decided to withdraw the recognition from the academic session 2008-2009 and as per the decision of SRC a withdrawal order was issued to the institution on 22.10.2008 for the proposed B.Ed course as per section 15(3)(b) of NCTE Act.

3. AND WHEREAS, the applicant institution preferred an appeal under Section 18 of NCTE Act, before NCTE, New Delhi. The applicant Authority considering the appeal passed an order vide F.No. 89-360/2008 dated 09.02.2009 confirming the decision of SRC. Further the institution has approached Hon'ble High Court of Andhra Pradesh in writ petition No. 3609 of 2009. The court has passed an order dt. 02.08.2010.

4. AND WHEREAS, the SRC in its 197th meeting held on 13th-14th October, 2010 considered the matter and all the relevant documents and it was decided to issue Show Cause Notice under section 17 of NCTE Act. Accordingly, a Show Cause Notice was issued to the institution for seeking clarification on 01.12.2010. The institution has submitted its written representation on 03.01.2011.

5. AND WHEREAS, the SRC in its 201st meeting held on 22nd-23rd February, 2011 considered the matter and decided to cause inspection.

6. AND WHEREAS, the committee in its 204th meeting held on 27th-28th April, 2011, considered the VT Report, VCD and all the relevant documentary evidences and it was decided to serve show cause notice to issue SCN. As per direction of SRC, SCN was issued to the applicant institution on 26.05.2011. in response to this office letter dt. 26.05.2011 the institution has submitted reply vide letter dt. 22.06.2011.

7. AND WHEREAS, the committee in its 208th meeting of SRC held on 13th-14th July, 2011, considered the VT report, reply of the institution dt. 22.06.2011 and other related documents along with the original file of the institution for shifting to new/permanent premises and decided to permit shifting to new premises/building.

8. **AND WHEREAS**, the SRC permission is hereby accorded by SRC to AM Reddy Educational Society, Chejera Post, Nakarikallu Mandal, Guntur District, Andhra Pradesh to shift the premises to new location/ building at A.M. Reddy College of Education, Sy No. 45/1, Pettluvari Palem Panchayath, Narasaraopeta Mandal, Guntur District- 522601, Andhra Pradesh vide order no. F.No.APSO7104/B.Ed/AP/2011-12/30096 dt. 05.09.2011.

9. **AND WHEREAS**, the Southern Regional Committee in its 284th meeting held during 9th to 10th April, 2015 considered the matter, all the relevant documents of the institution, approved staff list received from Registrar, Acharya Nagarjuna University, Nagarjuna Nagar, and decided to serve Notice Under NCTE Act for the following deficiencies :-

1. Lact (Fine Arts) not approved.

10. **AND WHEREAS**, after promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 20.01.2015. A revised provisional recognition order was issued to the institution on 26.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.

11. **AND WHEREAS**, the institution vide letter dt. 06.05.2015 submitted reply to the show cause notice on 11.05.2015 and the SRC in its 290th meeting held on 10th-11th July 2015 considered the matter and decided as under:

Rectification of faculty deficiency noted.

12. **AND WHEREAS**, the SRC in its 381st meeting held on 31st Oct & 01st, Nov, 2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT Report not accompanied with the requisite document. On perusal of the records, it is found that the institution has not submitted reply to the SCN. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 19.11.2019. The institution vide latter dt. 15.06.2020 submitted reply to the alongwith land & building documents having address as Survey No. 54/1, 54/2, Petlurivaripalem (Panchayat), Narasaraopet, Guntur District – 522601, Andhra Pradesh and staff list etc.

13. **AND WHEREAS**, the SRC in its 387th meeting held on 24th – 25th August, 2020 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply submitted by the institution vide letter dt. 15.06.2020, Committee decided that the **continuation order** be issued to the Institution **A.M. Reddy College of Education, Guntur District – 522601, Andhra Pradesh** for B.Ed programme for 2 basic units of 50 students each.

14. NOW THEREFORE, this order is issued permitting the institution i.e. A.M. Reddy College of Education, Survey No. 54/1, 54/2, Petlurivaripalem (Panchayat), Narasaraopet, Guntur District – 522601, Andhra Pradesh run by Atluri Masthan Educational Society, Guntur-522601, Andhra Pradesh for continuation of recognition for B.Ed course of two years duration with an intake of 100 students (2 basic units) of subject to fulfillment of the following conditions:-

I.The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.

II.The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.

III.The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.

IV.The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

15. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

16. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

17. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution;
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter;
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;

- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

18. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

19. The institution shall make available the list of students admitted on its official website.

20. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
