Whereas, the institution namely Annai Fathima College of Education, Kovilacheri Post, Kumbakonam District, Tamilnadu-612503 was granted recognition vide SRC, NCTE order No. F.SRO/NCTE/B.Ed./2007-2008/16508 dt. 02.01.2008 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

And Whereas, the institution namely Annai Fathima College of Education, Plot No. 64/2B, Kovilacheri Village & Post, Kumbakonam Taluk, Thanjavur District, Tamilnadu-612503 for conducting B.Ed. (Additional Intake) course with an annual intake of 200 vide order no. F.SRO/NCTE/SRCAPP37/B.Ed.-AI/TN/2015/62177 dt. 03.03.2015.

And Whereas, after the promulgation of NCTE Regulations, 2014 and as per affidavit submitted by the institution on dt. 04.03.2015 for B.Ed. course & B.Ed.-AI course with an annual intake of 200 students and the provisional revised recognition order was issued on dt. 05.05.2015 to the institution for conducting B.Ed. programme of two years duration with an annual intake of 100 students each for two basic units and respect of B.Ed.-AI course the provisional revised recognition order was issued on dt. 21.04.2015 for conducting programme of two years duration with an annual intake of 100 for two basic units of 50 students each from the academic session 2015-2016.

And Whereas, the matter regarding compliance by the institutions of the conditions of the revised recognition order was placed before the SRC in its 369th meeting held on 28.01.2019 and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance.

And Whereas, a Show Cause Notice was issued to the institution on 25.10.2019.

And Whereas, in response the institution submitted reply to the Final Show Cause Notice on dt. 19.11.2019 & 05.12.2019 were considered by the SRC in its 383rd meeting held on 07th & 09th January, 2020 and Committee decided to constitute VT of the Institution to assess infrastructural & instructional facilities of both the institutions.

And Whereas, as per the direction of SRC, the inspection was conducted on 13.02.2020 and 14.02.2020 and VT report received in the office of SRC on 20.01.2020.

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

On the perusal of the records made available in the original file, the Committee considered the VT report dt. 20.01.2020. Committee decided that the **continuation order** be issued to the Institution **Annai Fathima College of Education**, **Kovilacheri Post**, **Kumbakonam District**, **Tamilnadu-612503** for **B.Ed** programme for **4 basic units of 50 students**."

Now Therefore, the SRC decided to permit the institution i.e. Annai Fathima College of Education, Kovilacheri Post, Kumbakonam District, Tamilnadu-612503 for B.Ed. course run by Church of South India Trust Association, Kanyakumari Diocese for continuation of recognition for B.Ed. course of two-years duration with an annual intake of 200 students (four basic units) subject to fulfilment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
 - V. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 10. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.
- 11. The institution shall submit to the Regional Committee a Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

- 12. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
 - e. Fee charged from students.
 - f. Available infrastructural facilities.
 - g. Facilities added during the last quarter.
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information, if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 13. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

14. The institution shall make available the list of students admitted on its official website.

15. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
