ORDER

WHEREAS, the recognition was granted to the institution namely **Hameed Piyare College of Education, No. 7-95, Barey Manzil, Mominpura, Gulbarga District, Karnataka** run by **Syed Barey Educational and Charitable Trust, Gulbarga, Karnataka** vide SRC (NCTE) order no. F.SRO/NCTE/APS01891/B.Ed/2005-2006/5138 dt. 06.01.2006 for conducting **Secondary (B.Ed.)** course of one-year duration with an annual intake of 100 students.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 22.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 16.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.

3. **AND WHEREAS**, the matter was further considered by the sub-committee constituted by the SRC as per its decision taken in 380th meeting. The sub-committee decided to issue First Show Cause Notice to all such institution where reply to SCN has not been submitted by the institution. Accordingly, as per the decision of SRC a First Show Cause to the institution on 23.10.2019. The institution submitted its reply to the First Show Cause Notice vide letter dt. 25.11.2019.

4. **AND WHEREAS**, the institution vide letter no HPCE/B.Ed./APSO1891/2019-20 dated 27.01.2020 submitted written representation. The SRC in its 384th Meeting held on 12th-13th February 2020 considered the matter and decided to constitute VT for shifting of premises of **Hameed Piyare College of Education, Karnataka**

5. **AND WHEREAS**, as per the direction of the SRC the inspection was conducted on 16.03.2020. and the VT Report received in this office on 19.03.2020 alongwith land & building documents having address as **H No. 7-95, Barey Manzil, Mominpura, Gulbarga District-585104, Karnataka** and staff list etc.

6. **AND WHEREAS**, the SRC in its 387th meeting held on 24th – 25th August, 2020 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by

the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply submitted by the institution vide letter dt. 23.10.2019, Committee decided that the **continuation order** be issued to the Institution **Hameed Piyare College of Education, Gulbarga District, Karnataka-585104** for B.Ed programme for **2 basic units of 50 students each**.

7. **NOW THEREFORE**, this order is issued permitting the institution i.e. **Hameed Piyare College of Education, H No. 7-95, Barey Manzil, Mominpura, Gulbarga District-585104, Karnataka** run by **Syed Barey Educational and Charitable Trust, Gulbarga-585104, Karnataka** for continuation of recognition for B.Ed course of two years duration with an intake of 100 students (**2 basic units**) of subject to fulfillment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

8. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.

9. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.


10. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.

- c. Name of faculty members who left or joined during the last, quarter;
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e. Fee charged from students;
 - f. Available infrastructural facilities;
 - g. Facilities added during the last quarter;
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information, if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
11. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
12. The institution shall make available the list of students admitted on its official website.
13. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
