ORDER

WHEREAS, Dr. KSPR College of Education, Kesanupalli Post Office, Narasaraopet Mandal, Guntur District, Andhra Pradesh had submitted an application to the Southern Regional Committee of NCTE for grant of recognition for Secondary (B.Ed.) course of one year duration with an annual intake of 100 students.

2. AND WHEREAS, the recognition of the institution namely Dr. Kodela Siva Prasada Rao College of Education, Vinukonda Road, (old) Engineering College Campus, Narasaraopet – 522601, Guntur District, Andhra Pradesh was refused vide SRC (NCTE) order no. F.AP/NEW/B.Ed/301/2003-2004/631 dated 08.01.2004 for conducting B.Ed. course of one-year duration.

3. AND WHEREAS, aggrieved by the refused order, the institution preferred an appeal to NCTE-Hqrs. The Appellate Authority in its order vide letter no. F.No. 89-39/2004/Appeal/speed post dated 17.06.2004 the Council hereby reverses the Orders appealed against by granting recognition to Dr. Kodela Siva Prasada Rao College of Education, Vinukonda Road, (old) Engineering College Campus, Narasaraopet – 522601, Guntur District, Andhra Pradesh.

4. AND WHEREAS, the institution submitted shifting proposal dated 26.09.2007 along with DD of Rs.40,000/- bearing No.791550 of SBI, dated 21.09.2007 for processing fee.

5. AND WHEREAS, as per the decision of SRC, a composite inspection was conducted on 10.02.2011 and Visiting team report is received by this office on 15.02.2011. The matter was placed before the SRC in its 211th meeting held on 21st - 23rd September, 2011 and the Committee decided to issue Show Cause Notice.

6. AND WHEREAS, the SRC considered the matter in its 211th Meeting of SRC held on 21st – 23rd September, 2011 and thereafter considered the matter in its 217th meeting held on 08th & 09th February, 2012 and the Committee decided the matter as provided below:

"The committee considered the reply of the institution vide letter dt. 28.11.2011 and all other relevant documentary evidence and decided to allow for shifting of the institution to the new premises, on payment of Rs.40000/- towards inspection fee."

7. **AND WHEREAS**, as per decision of SRC a letter was issued to the institution on 14.03.2012. The institution submitted shifting of the institution to the new premises dated 13.04.2012 along with DD of Rs.40,000/- bearing No.509074 of SBH, dated 03.04.2012.

8. **AND WHEREAS**, the SRC vide order no. F.No.APS01308/B.Ed/AP/2011-12/47165 dt. 08.11.2012 was issued to the institution for shifting of premises to new location at **Vinkonda Road, Kesanupalli Post, Narasaraopet Mandal, Guntur District, Andhra Pradesh**

9. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dated 24.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 14.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.

10. **AND WHEREAS**, the institution submitted written representation requesting for reduction of strength from 200 to 50 (one basic unit) in its B.Ed & B.Ed-AI course on 23.12.2015 and SRC decided the following:-

1. *Request for reduction of B.Ed. from 4 units to 1 unit is accepted.*
2. *Recognition is withdrawn for B.Ed. AI (APSO8534) and for 2nd unit of B.Ed. (APSO1308).*
 1. *Issue LOI for M.Ed. (1 unit).*
 2. *FDRs in Joint account should be furnished.*
 3. *Only if these are given on or before 3.3.16 can issue of Formal Recognition w.e.f. 2016-2017 academic year be possible*
1. *Issue LOI for D.El.Ed.-AI (1 units)*
2. *For D.El.Ed (basic unit) and D.El.Ed-AI combined staff list should be produced in accordance with the norms given in 2014 Regulations*
3. *FDRs in Joint account should be furnished.*
4. *Only if these are given on or before 3.3.16 can issue of Formal Recognition w.e.f. 2016-17 academic year be possible.*

11. **AND WHEREAS**, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision of SRC a Show Cause Notice issued on 19.02.2019. The institutions vide letter dated 07.05.2019 & 18.05.2019 submitted reply to the alongwith land & building documents having address as **S.No. 50/1D, 50/1F, 51/2A, 51/2B, 51/2C, 51/2D, 137/1E Kesanupalli Village, Narasaraopet Mandal, Guntur District-522601, Andhra Pradesh** and staff list etc.

12. **AND WHEREAS**, the SRC in its 387th meeting held on 24th – 25th August, 2020 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply submitted by the institution vide letter dt. 08.05.2019, Committee decided that the continuation order be issued to the Institution **Dr. Kodela Siva Prasad Rao College of Education, Guntur District, Andhra Pradesh** for B.Ed programme for 2 basic units of 50 students each.

13. **NOW THEREFORE**, this order is issued permitting the institution i.e. **Dr. Kodela Siva Prasad Rao College of Education, S.No. 50/1D, 50/1F, 51/2A, 51/2B, 51/2C, 51/2D, 137/1E Kesanupalli Village, Narasaraopet Mandal, Guntur District-522601, Andhra Pradesh** run by **St. Joseph Educational Society, Door No. 12-9-1/10, Parkash Nagar, Narasaopet, Guntur District-522601, Andhra Pradesh** for continuation of recognition for B.Ed course of two years duration with an intake of 100 students (2 basic units) of subject to fulfillment of the following conditions:-

I.The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.

II.The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.

III.The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.

IV.The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

14. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

15. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

16. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter:

- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

17. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

18. The institution shall make available the list of students admitted on its official website.

19. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
