WITHDRAWAL ORDER

WHEREAS, recognition u/s15 (3)(a) of NCTE Act, 1993 was granted to the institution namely, R.G. Reddy Teacher Training institute, Telkapally Mandal, Nagar Kurnool Division, Mahabubnagar District, Pin-509385,Andhra Pradesh run by C.L.R. Educational society, Telkapally Mandal, Nagar Kurnool Division, Mahabubnagar District, Pin-509385, Andhra Pradesh vide SRC (NCTE) order no. F.No.APS02825/D.Ed. /AP/2012/46015 dated 11.09.2012 for conducting D.Ed. Course of two years duration with an annual intake of 50 students from the academic session 2012-2013.

- **2. AND WHEREAS,** a letter dated 16.08.2022 has submitted by the management of the institution for closure of D.Ed. Programme.
- 3. AND WHEREAS, the SRC in its 418th Meeting of SRC held on 16th December 2022 considered the matter for closure of the D.Ed. Programme and decided as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee noted that the institution has not filled Performance Appraisal Report (PAR)

The Committee agreed to close down the institution as requested by the Institution vide letter dated 16.08.2022 by withdrawing the recognition granted to R.G. Reddy Teacher Training institute, Telkapally Mandal, Nagar Kurnool Division, Mahabubnagar District, Pin-509385, Telangana for conducting D.Ed. Programme under clause 17(1) of NCTE Act, 1993 from the academic session 2022-2023.

- 4. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby agreed to close down the institution as requested by withdrawing recognition granted to R.G. Reddy Teacher Training institute, Telkapally Mandal, Nagar Kurnool Division, Mahabubnagar District, Pin-509385, Telangana for conducting D.Ed. Course (now D.El.Ed. Programme) of two years duration with an annual intake of 50 students with effect from the academic session i.e., 2022-2023 onwards.
- 5. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act, 1993: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under subsection (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

"यदि कोई संस्था उप-धारा (1) के तहत मान्यता वापस लेने के आदेश के लागू होने के बाद शिक्षक शिक्षा में कोई पाठ्यक्रम या प्रशिक्षण प्रदान करती है या जहां कोई संस्थान नियत दिन से ठीक पहले शिक्षक शिक्षा में पाठ्यक्रम या प्रशिक्षण प्रदान करने में विफल रहता है या इस अधिनियम के तहत मान्यता या अनुमित प्राप्त करने हेतु उपेक्षा करता है, तो ऐसे पाठ्यक्रम या प्रशिक्षण के अनुसार या ऐसी संस्था में पाठ्यक्रम या प्रशिक्षण लेने के बाद प्राप्त शिक्षक शिक्षा में योग्यता को केंद्र सरकार, किसी राज्य सरकार या विश्वविद्यालय या केन्द्रीय सरकार या किसी राज्य सरकार द्वारा सहायता प्राप्त किसी स्कूल, कॉलेज या अन्य शैक्षिक संस्था में रोजगार के उद्देश्य के लिए वैध योग्यता के रूप में नहीं माना जाएगा।")
