**WITHDRAWAL ORDER**

WHEREAS, recognition u/s14 (3)(a) of NCTE Act, 1993 was granted to the institution namely, Sanjeevani College of Education, Survey No.30, 31, P.No. 7-162-6, Kondamallepally Village and Post, Devarakonda Taluk and City, Nalgonda District, Pin-508243, Andhra Pradesh run by Sanjeevani Charitable Trust, P.No.7-162/6, Sagar Road, Kondamallepally Village and Post, Devarakonda Taluk and City, Nalgonda District, Pin-508243, Andhra Pradesh vide SRC (NCTE) Order No. F.No.SRCAPP1540/D.El.Ed./AP/2012/44927 dated 03.08.2012 for conducting D.El.Ed. Course of two years duration with an annual intake of 50 students from the academic session 2012-2013.

2. AND WHEREAS, the SRC in its 360<sup>th</sup> meeting held on 17<sup>th</sup> & 18<sup>th</sup> March 2018 considered the matter and rejected the request for transfer the management. Accordingly, as per direction, a letter dated 31.05.2018 was issued to the institution.

3. AND WHEREAS, the SRC in its 413<sup>th</sup> meeting held on 22<sup>nd</sup> – 23<sup>rd</sup> August 2022 the Committee discussed in detail about the institutions who failed to submit the PAR as advised by the NCTE. The Regional Director, SRC jurisdictional area and serve a Show Cause Notice for failure of submitting the PAR to all such institutions seeking infrastructural & instructional details along with GIS location etc. Accordingly, as per the decision of SRC, a Show Cause Notice was issued to the institution on 01.01.2022.

4. AND WHEREAS, a letter dated 14.11.2022 has submitted by the management of the institution for closure of D.El.Ed. Programme.

5. AND WHEREAS, the SRC in its 418<sup>th</sup> Meeting of SRC held on 16<sup>th</sup> December 2022 considered the matter for closure of the D.El.Ed. Programme and decided as under: -

***"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -***

**The Committee noted that the institution has not filled Performance Appraisal Report (PAR)**

***The Committee agreed to close down the institution as requested by the Institution vide letter dated 14.11.2022 by withdrawing the recognition granted***

to Sanjeevani College of Education, Survey No.30, 31, P.No. 7-162-6, Kondamallepally Village and Post, Devarakonda Taluk and City, Nalgonda District, Pin-508243, Telangana for conducting D.Ed. Programme under clause 17(1) of NCTE Act, 1993 from the academic session 2022-2023.

**However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC in its earlier meeting".**

6. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby agreed to close down the institution as requested by withdrawing recognition granted to **Sanjeevani College of Education, Survey No.30, 31, P.No. 7-162-6, Kondamallepally Village and Post, Devarakonda Taluk and City, Nalgonda District, Pin-508243, Telangana** for conducting D.El.Ed. Programme of two years duration with an annual intake of **50 students** with effect from the academic session i.e., 2022-2023 onwards.

7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act, 1993: -

**"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."**


**"यदि कोई संस्था उप-धारा (1) के तहत मान्यता वापस लेने के आदेश के लागू होने के बाद शिक्षक शिक्षा में कोई पाठ्यक्रम या प्रशिक्षण प्रदान करती है या जहां कोई संस्थान नियत दिन से ठीक पहले शिक्षक शिक्षा में पाठ्यक्रम या प्रशिक्षण प्रदान करने में विफल रहता है या इस अधिनियम के तहत मान्यता या अनुमति प्राप्त करने हेतु उपेक्षा करता है, तो ऐसे पाठ्यक्रम या प्रशिक्षण के अनुसार या ऐसी संस्था में पाठ्यक्रम या प्रशिक्षण लेने के बाद प्राप्त शिक्षक शिक्षा में योग्यता को केंद्र सरकार, किसी राज्य सरकार या विश्वविद्यालय या केन्द्रीय**



सरकार या किसी राज्य सरकार द्वारा सहायता प्राप्त किसी स्कूल, कॉलेज या अन्य शैक्षिक संस्था में रोजगार के उद्देश्य के लिए वैध योग्यता के रूप में नहीं माना जाएगा।")

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website [www.ncte.gov.in](http://www.ncte.gov.in) within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
