F.AP/B.Ed./New/55/SRO/NCTE/2000-2001/1223 dt 17.07.2000 for conducting B.Ed. course of one-year duration with an annual make of 100 students.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt. nil for its willingness for adherence of provisions of new Regulations.

AND WHEREAS, a revised provisional recognition order was issued to the institution on 12.05.2015 for conducting B.Ed course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.

AND WHEREAS, the SRC issued a Corrigendum vide Order No. F.SRO/NCTE/AOS00519 /B.Ed./AP/2015/72381 dated 07.08.2015 to the institution reduce intake of 2 units to 1 unit.

AND WHEREAS, the institution vide letter dated 21.09.2020 submitted written representation for closing of the institution. The SRC in its 389th Meeting held on 12th & 14th October, 2020 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Shri Balaji College of Education, Dharmavaram Road, Kothacheruvu-515133, Ananthpur District, Andhra Pradesh for conducting B.Ed. programme of two year duration with an annual intake of 50 students (1 unit) w.e.f. the next academic session.
