WITHDRAWAL ORDER**

WHEREAS, the recognition was granted to the institution namely Shri Balaji College of Education, Dharmavaram Road, Kothacheruvu-515133, Ananthpur District, Andhra Pradesh run by Sri Balaji Educational Society, Dharmavaram Road, Kothacheruvu-515133, Ananthapur District, Andhra Pradesh vide SRC (NCTE) order no. F.AP/B.Ed./New/55/SRO/NCTE/2000-2001/1223 dt 17.07.2000 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt. nil for its willingness for adherence of provisions of new Regulations.

AND WHEREAS, a revised provisional recognition order was issued to the institution on 12.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.

AND WHEREAS, the SRC issued a Corrigendum vide Order No. F.SRO/NCTE/AOS00519/B.Ed./AP/2015/72381 dated 07.08.2015 to the institution reduce intake of 2 units to 1 unit.

AND WHEREAS, the institution vide letter dated 21.09.2020 submitted written representation for closing of the institution. The SRC in its 389<sup>th</sup> Meeting held on 12<sup>th</sup> & 14<sup>th</sup> October, 2020 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

- (a) NOC from the affiliating body.
- (b) NOC from the staff/faculty.
- (c) Resolution of the management to the effect for closure of the course

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Shri Balaji College of Education, Dharmavaram Road, Kothacheruvu-515133, Ananthpur District, Andhra Pradesh for conducting B.Ed. programme of two year duration with an annual intake of 50 students (1 unit) w.e.f. the next academic session.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
