ORDER

WHEREAS, the recognition was granted to the institution namely Vidyalaya College of Education, Chittor District, Andhra Pradesh vide SRC (NCTE) order no. F.AP/NEW/B.Ed/88/SRO/NCTE/2002-2003/6717 dated 04.04.2003 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

- 2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 19.01.2015. A revised provisional recognition order was issued to the institution on 06.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.
- 3. AND WHEREAS, the SRC issued a letter for shifting of the institution to the New / Permanent premises vide order no. F.SRO/NCTE/APSO0033/2009-2010/24116 dated 03.12.2010.
- 4. AND WHEREAS, the SRC in its 314th meeting held during 27th & 38th May 2016 considered the reply of the revised order and decided to issue intimation inspection letter. As per the decision of SRC an inspection letter was issued to the institution on 14.06.2016. A letter is received on 06.07.2016 this office from the institution. The SRC in its 318th meeting held on 8th-9th August 2016 considered the matter and decided as under: -
 - 1. According to earlier VT inspection report, built-up area is adequate. Therefore, another inspection is not required.
 - 2. They have given a Faculty list that is approved by competent authority. But they have not given the original faculty list.
- 5. AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, a Show Cause Notice issued on 13.05.2019. The institution has not submitted reply to Show Cause Notice.
- 6. AND WHEREAS, the SRC in 381th meeting held on 31st Oct & 1st Nov, 2019 decided to issue Show Cause Notice to all such institution where compliance/representation has not been submitted by the institution. Accordingly, as per the decision of SRC a Final show cause notice

was issued to the institution on **06.12.2019**. The institution vide dated **31.01.2020** submitted reply to the Final Show Cause Notice.

7. AND WHEREAS, the SRC in its 388th meeting held on 14th to 15th September, 2020 considered the matter and decided to issue withdrawal order. Accordingly, as per the decision of SRC withdrawal order no. F.SRO/NCTE/APS00033/B.Ed/AP/2 020/118733-8739 dated 24.09.2020 was issued to the institution.

- 8. AND WHEREAS, on perusal of the records it is submitted that the institution was allowed shifting of the premises vide order/letter dated 03.12.2010. Further the institution vide letter dated 05.10.2020 has represented. The SRC in its 389th meeting held on 12th & 14th October, 2020 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC Final Show Cause Notice was issued to the institution on 16.10.2020. The institution vide letter dated 26.10.2020 reply to alongwith land & building documents having address as Sy. No. 10/1A, 1B, 1C, 4-32, SBI Colony, Renigunta Road, Thimminaidu Palem Gram Panchayat, Tirupati (Rural) 517507, Andhra Pradesh and staff list etc.
- 9. AND WHEREAS, the SRC in its 390th meeting held on 28th 29th October, 2020 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply submitted by the institution vide letter dt. 31.01.2020, the Committee decided that the continuation order be issued to the Institution Vidyalaya College of Education, Chittor Dt, Andhra Pradesh for B.Ed programme for 2 basic units of 50 students each unit.

- 10. NOW THEREFORE, this order is issued permitting the institution i.e. Vidyalaya College of Education, Sy. No. 10/1A, 1B, 1C, 4-32, SBI Colony, Renigunta Road, Thimminaidu Palem Gram Panchayat, Tirupati (Rural) 517507, Andhra Pradesh run by Shiridi Sai Educational Society, 19-8-150, Rayalaseema Nagar, Bairagipatteda, Tirupati 517501, Andhra Pradesh for continuation of recognition for B.Ed. course of two years duration with an intake of 100 students (2 units) of subject to fulfillment of the following conditions:-
 - I.The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II.The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.

- III.The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 11. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 12. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 13. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e. Fee charged from students;
 - f. Available infrastructural facilities;
 - g. Facilities added during the last quarter;
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information, if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 14. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 15. The institution shall make available the list of students admitted on its official website.
- 16. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself

vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
