WHEREAS, the recognition was granted to the institution namely V.C.R. College of Education, Mittoor, Chittoor-517001, Andhra Pradesh run by Smt. Lakshamamma & Srinivasula Reddy Educational Society, Mittoor, Chittoor-517001, Andhra Pradesh vide SRC (NCTE) order no. F.AP/NEW/B.ED/129/SRO/NCTE/2002-2003/6716 dt 04.04.2003 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 28.01.2015 for its willingness for adherence of provisions of new Regulations.

AND WHEREAS, as per RPRO vide order no. F.SRO/NCTE/APS00353/B.Ed/AP/2015-16/64283 dated 11.05.2015 on scrutiny it is found that the institution has not shifted to its own premises as stipulated in its Formal Recantation order dated 0 104.2003.

AND WHEREAS, the institution has submitted a written representation on 09.07.2015 With reference to the above, we are herewith submitting the proposal for shifting of the college premises to the Permanent building with all the documents and also a Demand Draft no. 245539 dt: 06.07.2015 for Rs.1,50,000/- of Bank of Baroda, Chittoor Branch towards inspection fee.

AND WHEREAS, the institution has submitted a written representation (Request for one basic unit of 50 students) on 27.01.2016. The SRC in its 307<sup>th</sup> meeting held on 09<sup>th</sup> March 2016 considered the mater and decided as under:-

- No documents have been furnished.
- 2. Give another opportunity.
- 3. Caution them that unless documents are given recognition will be withdrawn.

AND WHEREAS, the institution submitted a written representation on 14.03.2016. The SRC in its 315<sup>th</sup> meeting held on 17<sup>th</sup> & 18<sup>th</sup> June, 2016 has considered the written representation of the institution dated 14.03.2016 has decided as under:

- 1. BP is not approved by competent authority.
- 2. Latest faculty list and original FDRs are not given.
- 3. All other documents are in order.
- 4. Inspection fee has been paid.
- 5. Cause inspection for shifting B.Ed (1 unit).
- 6. They have requested for reduction from B.Ed (2 units) to B.ed (1 unit). Permission is given. The recognition for the 2<sup>nd</sup> unit of B.Ed is withdrawn. Issue a revised Formal Recognition accordingly after decision in the shifting matter.

AND WHEREAS, as per the decision of SRC a letter was issued to the institution on 13.07.2016. The institution has submitted the affidavit for offering B.Ed course with an intake of 50 students on 07.08.2016. As per the direction of SRC, the inspection of the institution was conducted on 07.09.2016 and the VT Report received in the office of SRC on 15.09.2016.

AND WHEREAS, the SRC in 381<sup>th</sup> meeting held on 31<sup>st</sup> Oct & 1<sup>st</sup> Nov, 2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT Repost accompanied with requisite documents. Accordingly, as per the decision of SRC a First show cause notice was issued to the institution on 06.12.2019. The institution submitted its reply received on 02.01.2020.

AND WHEREAS, the SRC in its 387<sup>th</sup> meeting held on 24<sup>th</sup> – 25<sup>th</sup> August, 2020 considered the matter and decided to issue Final Show Cause Notice u/s 17 of NCTE Act, 1993 before withdrawal of the recognition on the grounds mentioned above to the institution. The institution is required to submit the documents within 21 days from the date of issue of Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 07.09.2020. The institution vide letter dated 11.09.2020 and 18.09.2020 its reply to the Final Show Cause Notice.

AND WHEREAS, the SRC in its 389th Meeting held on 12th & 14th October, 2020 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The institution was issued a Final Show Cause Notice (FSCN) dated 07.09.2020. The institution has submitted its reply on 23.09.2020. The Committee observed the reply submitted by the institution and found the following deficiencies.

- 1. The inspection was carried out on date 07.09.2016 of the institution namely VCR College of Education address S.No. 220-5, Mapakshi Village, Chittor District, Andhra Pradesh. Now, the institution has submitted all documents regarding Land and other requisite documents pertaining to the land which found different at S.no 160/3, Anupalle Revenue Village, Chittoor District, Andhra Pradesh.
- 2. The Site Area / Land Area is not mentioned in the Building Plan submitted by the institution.
- 3. The institution has not submitted Latest Staff List (in prescribed format) duly approved by the concerned affiliating university.
- 4. The institution has not submitted "Form A" issued by the respective Bank Manger towards creation of FDR of Rs. 4 lakh towards Endowment Fund & Reserve Fund into joint account for a duration of 5 years with a copy of the FDRs

Hence, the Committee decided to withdraw the recognition granted to V.C.R. College of Education, Mittoor, Chittoor-517001, Andhra Pradesh for conducting B.Ed course w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of V.C.R. College of Education,

Chittoor Revenue Division, 19-278, Mittoor, Chittoor-517001, Andhra Pradesh for conducting B.Ed. programme of two year duration with an annual intake of 100 students (2 units) w.e.f. the next academic session.

Further, the institution and affiliating body is hereby informed about the following-provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="https://www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
