WHEREAS, the recognition was granted to the institution namely Ghulam Ahmed Elementary Teacher Education College, No. 8-2-249, Road No. 3, Banjara Hills, Hyderabad — 500034, Andhra Pradesh run by Sultan — UI — Uloom — Education Society, Road No. 3, Banjara Hills, Hyderabad — 500034, Andhra Pradesh vide SRC (NCTE) order no. F.SRC/I/CTE/APS02622/D.Ed/2005-2006/2625 dt. 26.08.2005 or conducting D.Ed. course of one-year duration with an annual intake of 50 students

AND WHEREAS a letter is received from the Director of School Education Government of Telangana Hyderabad vide letter No. Lr.No.159/N1-3/Ded/scert/2014 dated 24.04.2015 received in this office of SRC-NCTE on 06.05.2015 regarding defmission to conduct counselling for admission into D.El.Ed Course through Single Window-II AC into Muslim and Christian Minority Institutions for the academic year 2014-15-submission of NOC-Notice-Issued.

AND WHEREAS, the SRC in its 290th Meeting held on 10th & 11th July 2015, considered the matter, letter from the Director School Education Department, Telangana State and decided to:

 Issue Show Cause Notice to the institution for withdrawal of recognition for non submission of fire certificate by the college.

AND WHEREAS, as per the decision of SRC show cause notice was issued to the institution on 28.09.2015. The institution has submitted its written representation on 08.10.2015.

AND WHEREAS, the SRC in its 294th Meeting held on 14th-16th November, 2015, considered the letter received from the institution on 08.10.2015 requesting time to submit our compliance report and the committee decided that " Await submission of 'fire certificate' from GHMC". As per the decision of SRC, a letter was issued to the institution on 21.01.2016. Now, a letter received from the institution on 06.06.2016 alongwith Fire No Objection Certificate dated 05.08.2016.

AND WHEREAS, the institution vide letter dated 05.06.2020 submitted written representation for closing of the institution. The SRC in its 389th Meeting held on 12th & 14th October 2020 considered the matter and decided as under:-

The Committee decided to withdraw the recognition granted to Ghulam Ahmed Elementary Teacher Education College, No. 8-2-249, Road No. 3, Banjara Hills, Hyderabad – 500034, Telangana for conducting D.Ed course under clause 17(1) of NCTE Act, 1993 on its own request made vide letter dated 05.06.2020. However, the encashment of FDRs will be issued by the Regional Director on the submission of the following:

(a) NOC from the affiliating body.

(b) NOC from the staff/faculty.

(c) Resolution of the management to the effect for closure of the course

NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Ghulam Ahmed Elementary Teacher Education College, No. 8-2-249, Road No. 3, Banjara Hills, Hyderabad – 500034, Hyderabad – 500034, Telangana for conducting D.Ed. programme of two year duration w. an an order.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website appeal may be seen on NCTE's website.
