AND WHEREAS, the recognition was granted to the institution namely Vijay Bharathi College of Education, Sri Sai Nagar Phase-2, Opp Radio Relay Tower, Hayathnagar, Hyderabad — 501505, Telangana run by Kennedy Educational Society, Hyderabad, Telangana. The SRC vide order F.SRO/NCTE/APSO5935/B.Ed/2006-2007/2146 dt. 30.04.2007 for conducting (B.Ed.) course of two-year duration from the academic session 2006-07 with an annual intake of 100 students.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 17.02.2015. A Revised Provisional Recognition Order was issued to the institution on 06.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students (two units) from the academic session 2015-2016.
- 3. AND WHEREAS, the in its 363rd meeting held on 17th to 19th September, 2018 considered the matter and decided to issue Show Cause Notice. Accordingly, as per the decision of SRC Show Cause Notice was issued to the institution on 16.10.2018. The institution vide letter nil received on 11.01.2019 submitted its reply to the Show Cause Notice.
- 4. AND WHEREAS, the SRC in its 381st meeting held on 31st Oct & 01st Nov 2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents in response to RPRO issued by the SRC. Further the Committee also suggested on receiving the reply to the SCN, the SRO may scrutinize the documents and still if there are some deficiency/lapses, the RD is authorized to issue Final SCN and then place the cases before the SRC for its perusal and decision. Accordingly, a Final Show Cause Notice was issued to the institution on 25.11.2019.
- 5. AND WHEREAS, the institution vide dated 11.12.2019 submitted reply in response to the Final Show Cause Notice.
- 6. AND WHEREAS, the matter was further considered by the SRC in its 390th meeting held on October 28-29, 2020 and the Committee decided as follows: -

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

Jurisdiction : Andhra Pradesh, Telangana, Karnataka, Tamilnad Pudicherry, Andamana & Nikobar, Lakshadweep, Kerala The institution was issued a Final Show Cause Notice (FSCN) The institution has submitted its reply on 11.12.2019. The Committee observed the reply submitted by the institution and found the following deficiencies.

- 1. The institution has submitted photocopy of building plan/Site plan but not readable.
- 2. The institution has not submitted approval list of faculty affiliating body. Seven faculty Members (Assistant Professor) has not shown appointed date after promulgation of NCTE Regulations, 2017, and they do not possess NET/Ph.D qualification as per provisions of the NCTE Regulations, 2017.
- 3. The institution has submitted photocopy of Balance Certificate of Rs 8,47,449/- & 4,00757/-. The institution is required to submit a "Form A" issued by the respective Bank Manger towards creation of FDR of Rs.7 lakh and 5 lakh, totalling Rs.12 lakh towards Endowment Fund & Reserve Fund into joint account for a duration of 5 years along with a copy of the FDRs.
- 4. The institution has not mentioned the website details.

Hence, the Committee decided to withdraw the recognition granted to Vijay Bharathi College of Education, Sri Sai Nagar Phase-2, Opp Radio Relay Tower, Hayathnagar, Hyderabad – 501505, Telangana for conducting B.Ed course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

- 7. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Vijay Bharathi College of Education, Sri Sai Nagar Phase-2, Opp Radio Relay Tower, Hayathnagar, Hyderabad 501505, Telangana run by Kennedy Educational Society, Hyderabad, Telangana for conducting B.Ed. course of two years duration with an annual intake of 100 students w.e.f. the next academic session.
- 8. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
