WHEREAS, the recognition was granted to the institution namely Bhavani College of Education, Near 5th APSP Batallion, Boddavalasa Village, Denkad Mandal, Vizianagaram District-535005, Andhra Pradesh run by Bhavani Educational Society, Near 5th APSP Batallion, Boddavalasa Village, Denkad Mandal, Vizianagaram District-535005, Andhra Pradesh vide SRC (NCTE) order no. F. SRO/NCTE/B.Ed/2007-2008/14906 dt 19.11.2007 for conjucting B.Ed. course of one-year duration with an annual intake of 100 students.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 16.05.2015 for its willingness for adherence of provisions of new Regulations.

AND WHEREAS, as per RPF O vide order no. F.No/SRC/NCTE/APS07565/AP/2015, 6 dated 29,05,2015 on scrutiny it is found that the institution has not maintained/revalidated the Fixed Deposited Receipts towards Endowment and Reserve Funds:

AND WHEREAS, the institution submitted written representation on 28.09.2015 requesting for reduction of strength from 2 units to 1 unit in its B.Ed. course. The SRC issued a Corrigendum vide. Order No.F.SRO/NCTE/APS07565/B.Ed/AP/2015/77115 dated 27.10.2015 to the institution reduce intake of 2 units to 1 units.

AND WHEREAS, as per the decision 369th Meeting of SRC held on 28.01.2019 a Show Cause Notice to be issue to all such institution which have not submitted compliance. Accordingly, a show cause notice was issued to the institution on 01.03.2019. The institution vide letter dated 04.04.2019 submitted its reply to the show cause notice.

AND WHEREAS, the SRC in 381th meeting held on 31st Oct & 1st Nov, 2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT Repost accompanied with requisite documents. As per the decision of SRC a final show cause notice was issued to the institution on 07.11.2019. The institution has submitted on 10.12.2019 its reply to the Final Show Cause Notice.

AND WHEREAS, the SRC in its 389th Meeting held on 12th & 14th October, 2020 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The institution was issued a Final Show Cause Notice (FSCN) dated 07.11.2019. The institution has submitted its reply on 10.12.2019. The Committee observed the reply submitted by the institution and found the following deficiencies.

1. The institution has not submitted the certified copy of land document.

2. The Extent of the land is not mentioned in the Land Use Certificate submitted by the institution.

3. The institution has not submitted a notarized English version of NEC along with the original.

4. The institution has not submitted BCC in prescribed format duly approved by the

competent authority.

- 5. The institution has submitted photocopy of facility list approved by the Registrar, Andhra University, Visakhapatnam consisting of one principal, seven assistant professors submitted dated NIL.
  - a) Date of joining of lecturer is not mentioned in the facility list.

b) Principal does not possess a Ph.D. degree.

c) Faculty in r/o Fine Arts & Performing Arts not appointed.

6. The institution has not submitted Form 'A' issued by the Branch Manager. The institution is required to submit Form "A" issued by the bank manager for creation of FDR of Rs. 7 lakh & Rs. 5 lakhs towards Endowment Fund & Reserve Fund.

7. The institution has not submitted affidavit regarding the land, building &

management.

Hence, the Committee decided to withdraw the recognition granted to Bhavani College of Education, Near 5<sup>th</sup> APSP Batallion, Boddavalasa Village, Denkad Mandal, Vizianagaram District-535005, Andhra Pradesh for conducting B.Ed course w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Bhavani College of Education, Near 5<sup>th</sup> APSP Batallion, Boddavalasa Village, Denkad Mandal, Vizianagaram District-535005, Andhra Pradesh for conducting B.Ed. programme of two year duration with an annual intake of 50 students (1 unit) w.e.f. the next academic session.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="https://www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
