WITHDRAWAL ORDER**

**WHEREAS**, the recognition was granted to the institution namely **Swamy Vivekananda College of Education, D.No.3/88, Mudigal Road, Marempalli, Kalyandurga, Anantapur-515001, Andhra Pradesh** run by **Balaji Educational Society, Ananthpur, Andhra Pradesh** vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed./2007-2008/11446 dt. 17.09.2007 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

**AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt. 29.01.2015 for its willingness for adherence of provisions of new Regulations.

**AND WHEREAS**, a revised provisional recognition order was issued to the institution on 06.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.

**AND WHEREAS**, a Corrigendum was issued to the institution vide order no. F.SRO/NCTE/APS07930/B.Ed./AP/2015-16/67066 on 31.05.2015 for conducting B.Ed. programme of two years duration with an annual intake of 50 students (one basic unit) from the academic session 2015-16.

**AND WHEREAS**, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369<sup>th</sup> meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, Show Cause Notice issued on 05.02.2019. The institution has not reply to Show Cause Notice.

**AND WHEREAS**, the SRC in its 381<sup>st</sup> meeting held on 31<sup>st</sup> Oct & 01<sup>st</sup> Nov 2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents in response to RPRO issued by the SRC. Further the Committee also suggested on receiving the reply to the SCN, the SRO may scrutinize the documents and still if there are some deficiency/lapses, the RD is authorized to issue Final SCN and then place the cases before the SRC for its perusal and decision. Accordingly, a Final Show Cause Notice was issued to the institution on **06.12.2019**. The institution has submitted reply in response to the Final Show Cause Notice on **30.12.2019**.

**AND WHEREAS**, the SRC in its 390<sup>th</sup> Meeting held on 28<sup>th</sup> & 29<sup>th</sup> October, 2020 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by

the institution were carefully considered by the SRC and the following observations were made:-

The institution was issued a Final Show Cause Notice (FSCN) The institution has submitted its reply on 30.12.2019. The Committee observed the reply submitted by the institution and found the following deficiencies.

- a) *The institution has submitted a Notarized copy of Land Document whereas a certified copy of the same is not submitted as under under NCTE Regulations, 2014 even after issuance of show cause notices.*
- b) *The institution has submitted a Notarized copy of Building Plan in which Multi-purpose Hall Area is less than the requirement of NCTE Regulations, 2014.*
- c) *The institution has submitted a copy of Faculty List for B.Ed. Course approved by Registrar, Sri Krishnadevaraya University consisting of one Principal and seven Lecturers, but the same is without date. Further,*
  - (i) *Faculty in r/o Physical Education, Fine Arts & Performing Arts are not appointed.*
  - (ii) *Principal does not have the qualification of P.hd./Net in education.*
  - (iii) *A letter regarding approval of faculty by the affiliating body has not submitted.*


Hence, the Committee decided to **withdraw the recognition granted to Swamy Vivekananda College of Education, D.No.3/88, Mudigal Road, Marempalli, Kalyandurga, Anantapur-515001, Andhra Pradesh** for conducting B.Ed course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

**NOW, THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of **Swamy Vivekananda College of Education, D.No.3/88, Mudigal Road, Marempalli, Kalyandurga, Anantapur-515001, Andhra Pradesh** for conducting B.Ed. programme of two year duration with an annual intake of 50 students (1 unit) w.e.f. the next academic session.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

**"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."**

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
