AND WHEREAS, the recognition was granted to the institution namely Vidyadhari College of Educational, Women's College Road, Besides LIC Office, Srikakulam District-532001, Andhra Pradesh run by Vidyadhari Education Society, Srikakulam District, Andhra The SRC vide order F.SRO/NCTE /AP/B.Ed/2008/5863 dt.06.10.2008 conducting (B.Ed.) course of two-year duration with an annual intake of 100 students.

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution by 2. consented to come under new Regulations vide a notarized affidavit dated 28.01.2015. A Revised Provisional Recognition Order was issued to the institution on 26.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students (two units) from the academic session 2015-2016.
- AND WHEREAS, an Order no.SRO/NCTE/APS07965/B.Ed./AP/2017-18/94098 dated 21.07.2017 was issued to the institution for conducting B.Ed. programme of two-year duration with an annual intake of 50 for one basic unit of 50 students.
- AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, Show Cause Notice issued on 18.02.2019. The institution has not submitted any reply to Show Cause Notice.
- AND WHEREAS, the SRC in its 381st meeting held on 31st Oct & 01st Nov 2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents in response to RPRO issued by the SRC. Further the Committee also suggested on receiving the reply to the SCN, the SRO may scrutinize the documents and still if there are some deficiency/lapses, the RD is authorized to issue Final SCN and then place the cases before the SRC for its perusal and decision. Accordingly, a Final Show Cause Notice was issued to the institution on 06.12.2019.
- AND WHEREAS, the institution vide dated 30.12.2019 submitted reply in response to the Final Show Cause Notice.
- AND WHEREAS, the matter was further considered by the SRC in its 390th meeting held on October 28-29, 2020 and the Committee decided as follows: -

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The institution was issued a Final Show Cause Notice (FSCN) The institution has submitted its reply on 30.12.2019. The Committee observed the reply submitted by the institution and found the following deficiencies.

- 1. The institution has submitted notarized copy of Land Document, but certified copy is not submitted.
- 2. The institution has submitted Notarized Land Use Certificate, but Diverted Area not mentioned.
- 3. The institution has submitted Notarized copy of **Building Plan and Site Plan** which is in the name of individual.
 - (i) Multipurpose Hall not mentioned.
 - (ii) Built-up area not mentioned.
 - (iii) Total plinth area not sufficient for B.Ed. 1 basic unit.
- 4. The institution has submitted Notarized copy of **Building Completion**Certificate which is in the name of individual & Built-up area is less than 1500sqm. as per NCTE Norms.
- 5. The institution has submitted photocopy of Faculty list vide dated 27.11.2018 approved by Register B.R. Ambedkar University consisting of one principal & Seven Lecturers.
 - (i) The Principal does not have the qualification of Ph.D. as per NCTE Norms.
 - (ii) Two Assistant Professor does not have NET/Ph.D. as per NCTE (Recognition Norms & Procedure) (Amendment) Regulations, 2017 dated 29.05.2017 notified on 09.06.2017.
 - (iii) The institution has not appointed the faculty of **Performing Arts, Fine Arts and Physical Education**.
- 6. The institution is required to submit a "Form A" issued by the respective Bank Manger towards creation of FDR of Rs.7 lakh and 5 lakh, totalling Rs.12 lakh towards Endowment Fund & Reserve Fund into joint account for a duration of 5 years along with a copy of the FDRs.

Hence, the Committee decided to withdraw the recognition granted to Vidyadhari College of Educational, Women's College Road, Besides LIC Office, Srikakulam District-532001, Andhra Pradesh for conducting B.Ed. course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

8. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to to Vidyadhari College of Educational, Women's College Road, Besides LIC Office, Srikakulam District-532001, Andhra Pradesh run by Vidyadhari Education Society, Srikakulam District, Andhra Pradesh for conducting B.Ed. course of two years duration with an annual intake of 50 students w.e.f. the next academic session.

9. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

10. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
