WHEREAS, the recognition was granted to the institution namely Tagore College of Education, Gudur Road, Kodumur, Kurnool District, Andhra Pradesh run by Tagore Rural Educational Ability Talent Society, Kurnool District, Andhra Pradesh vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed./2007-2008/16124 dt. 19.12.2007 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt. 22.01.2015 for its willingness for adherence of provisions of new Regulations.

AND WHEREAS, a revised provisional recognition order was issued to the institution on 06.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16

AND WHEREAS, the SRC in its 318th meeting held on 8th & 9th August 2016 and the Committee decided to issue Show Cause Notice. Accordingly, as per the decision of SRC Show Cause Notice was issued to the institution on 01.09.2016. The institution has submitted in response to Show Cause Notice vide letter dated 03.10.2016.

AND WHEREAS, the SRC in its 381st meeting held on 31st Oct & 01st Nov 2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents in response to RPRO issued by the SRC. Further the Committee also suggested on receiving the reply to the SCN, the SRO may scrutinize the documents and still if there are some deficiency/lapses, the RD is authorized to issue Final SCN and then place the cases before the SRC for its perusal and decision. Accordingly, a Final Show Cause Notice was issued to the institution on 06.12.2019. The institution vide dated 19.12.2019 submitted reply in response to the Final Show Cause Notice

AND WHEREAS, the SRC in its 389th Meeting held on 12th & 14th October, 2020 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The institution was issued a Final Show Cause Notice (FSCN) dated 06.12.2019. The institution has submitted its reply on 19.12.2019. The Committee observed the reply submitted by the institution and found the following deficiencies.

- 1. The institution has submitted a certificate as LUC in which Diverted Area is not mentioned.
- 2. The institution has submitted BCC which is not in prescribed format as per NCTE.
- 3. The institution has submitted a Notarized copy of Faculty List approved by Dean, College Development Council Rayalaseema University consisting of one Principal and Fifteen Lecturers submitted vide dated 09:04. 2015. Some deficiencies are:
 - a. Principal does not have the qualification of Ph.D. in education.
 - b. The 9 Lecturers does not have NET/Ph.D. as per NCTE (Recognition Norms & Procedure) (Amendment) Regulations, 2017 dated 29.05.2017 notified on 09.06.2017.

Hence, the Committee decided to withdraw the recognition granted to Tagore College of Education, Gudur Road, Kodumur, Kurnool District, Andhra Pradesh for conducting B.Ed course w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

NOW, THEREFORE, in exercise of the powers vested u/s 7(1) of the NCTE Act, 1993 the Southern Regional Committee hereby withdraws recognition of Tagore College of Education, Gudur Road, Kodumur, Kurnool District-518464, Andhra Pradesh for conducting B.Ed. programme of two year duration with an annual intake of 100 students (2 units) w.e.f. the next academic session.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
