AND WHEREAS, the recognition was granted to the institution namely Chaitanya College of Education, P.S. Bonangi, Parawada Mandal, Visakhapatnam-530021, Andhra Pradesh run by Annapurna Educational and Charitable Society, Visakhapatnam District, Andhra Pradesh. The SRC vide order F.SRO/NCTE/B.Ed./2008-2009/4110 dt.22.08.2008 for conducting (B.Ed.) course of two-year duration from the academic session 2008-09 with an annual intake of 100 students.

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 28.01.2015. A Revised Provisional Recognition Order was issued to the institution on 12.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students (two units) from the academic session 2015-2016.
- AND WHEREAS, a Corrigendum was issued to the institution on 22.06.2015 vide order no. F.SRO/NCTE/APS09328/B.Ed./AP/2015/68060 on 22.06.2015 for conducting B.Ed. programme of two years duration with an annual intake of 50 students (one basic unit) from the academic session 2015-16.
- AND WHEREAS, the matter regarding compliance by the institutions of the 4. conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, Show Cause Notice issued on 25.04.2019. The institution has not reply to Show Cause Notice.
- AND WHEREAS, the SRC in its 381st meeting held on 31st Oct & 01st Nov 2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents in response to RPRO issued by the SRC. Further the Committee also suggested on receiving the reply to the SCN, the SRO may scrutinize the documents and still if there are some deficiency/lapses, the RD is authorized to issue Final SCN and then place the cases before the SRC for its perusal and decision. Accordingly, a Final Show Cause Notice was issued to the institution on 10.12.2019.
- AND WHEREAS, the institution vide dated 01.01.2020 submitted reply in response to the Final Show Cause Notice.
- AND WHEREAS, the matter was further considered by the SRC in its 390th meeting 7. held on October 28-29, 2020 and the Committee decided as follows: -

⊏ mail · cm@nata india am Mobello : unau cronoto in The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The institution was issued a Final Show Cause Notice (FSCN) The institution has submitted its reply on 01.01.2020. The Committee observed the reply submitted by the institution and found the following deficiencies.

- 1. The institution has not submitted a Notarized copy of Land Document whereas a photocopy of it submitted.
- 2. The institution has not submitted a Notarized copy of Land Use Certificate whereas a photocopy of it submitted.
- 3. The institution has not submitted a Notarized copy of NEC. However, a photocopy of NEC submitted.
- 4. The institution has not submitted a Notarized copy of Building Plan. However, a photocopy of Building Plan submitted in which Multi-purpose Hall Area is not mentioned.
- 5. The institution has not submitted a Notarized copy of Site Plan.
- 6. The institution has submitted a photocopy of completion certificate submitted which is not in prescribed format as per NCTE Norms.
- 7. The institution has submitted a photocopy of Faculty List for B.Ed. Course approved by Registrar, Andhra University, Visakhapatnam consisting of one Principal and eight Lecturers vide dated 22,12,2017.
 - a. One Lecturer does not have NET/Ph.D. as per NCTE (Recognition Norms & Procedure) (Amendment) Regulations, 2017 dated 29.05.2017 notified on 09.06.2017. He is appointed on 01.11.2018.
 - b. Teaching Subject is not mentioned.
 - c. The institution has failed to submit Notarized copy of Faculty list for the latest academic session.
- 8. The institution has failed to submit a "Form A" issued by the respective Bank Manger towards creation of FDR of Rs.7 lakh and 5 lakh, totalling Rs.12 lakh towards Endowment Fund & Reserve Fund into joint account for a duration of 5 years along with a copy of the FDRs.
- 9. Website is not working.

Hence, the Committee decided to withdraw the recognition granted to Chaitanya College of Education, P.S. Bonangi, Parawada Mandal, Visakhapatnam-530021, Andhra Pradesh for conducting B.Ed course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

8. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Chaitanya College of Education, P.S. Bonangi, Parawada Mandal, Visakhapatnam-530021, Andhra Pradesh run by Annapurna Educational and Charitable Society, Visakhapatnam District, Andhra Pradesh for conducting B.Ed. course of two years duration with an annual intake of 50 students w.e.f. the next academic session.

9. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

10. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
