WHEREAS, the recognition was granted to the institution namely Aadi Lakshmi College of Education, Survey No. 120/2, Navakhandavada, Pithapuram, East Godavari District-533450, Andhra Pradesh run by Bavisetti Kondala Rao Educational, Society, East Godavari District – 533450, Andhra Pradesh vide SRC (NCTE) order no. F. SRO/NCTE/B.Ed/2008/5564 dt 01.01.2008 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dated 13.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 20.03.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.

AND WHEREAS the institution submitted written representation on 12.10.2015 requesting for reduction of strength from 2 units to 1 unit in its B.Ed. course. Accordingly, order for reduction of strength from 2 units to 1 unit issued on 24.10.2015.

AND WHEREAS, the SRC in its 368th meeting held on 08th – 09th January, 2019 considered the matter and decided to issue Show Cause Notice. Accordingly, as per the decision of SRC a Show Cause Notice issued to the institution on 18.01.2019. The institution vide letter dated 29.01.2019 submitted reply to the show cause notice.

AND WHEREAS, the SRC in its 373rd meeting held on 26th – 27thMarch, 2019 considered the matter and decided to issue Show Cause Notice. Accordingly, as per the decision of SRC a Show Cause Notice issued to the institution on 08.04.2019. The institution vide letter dated 15.04.2019 submitted reply to the show cause notice.

AND WHEREAS, the SRC in its 376th meeting held on 11th – 12th June, 2019 considered the matter and decided to issue Show Cause Notice. Accordingly, as per the decision of SRC a show cause notice was issued to the institution on 01.07.2019. The institution submitted its reply to the show cause notice received on 17.07.2019.

AND WHEREAS, the SRC in its 380th meeting 18th – 19th September, 2019 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 25.09.2019 The institution submitted its reply to the Final Show Cause Notice received on 09.10.2019.

AND WHEREAS, the SRC in its 382^{nd} meeting held on $26^{th} - 27^{th}$ November, 2019 considered the matter and decided to issue last reminder letter. Accordingly, as per the decision of SRC Last Reminder Letter was issued to the institution on 05.12.2019. The institution vide letter dated nil received on 23.12.2019 submitted reply to the last reminder letter.

AND WHEREAS, the SRC in its 389th Meeting held on 12th & 14th October, 2020 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

 The institution has failed in submission of written representation along with required documents in response to Last Reminder (Letter).

Hence, the Committee decided to withdraw the recognition granted to Aadi Lakshmi College of Education, Survey No. 120/2, Navakhandavada, Pithapuram, East Godavari District- 533450, Andhra Pradesh for conducting B.Ed course w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Aadi Lakshmi College of Education, Survey No. 120/2, Navakhandavada, Pithapuram, East Godavari District-533450, Andhra Pradesh for conducting B.Ed. programme of two year duration with an annual intake of 50 students (1 unit) w.e.f. the next academic session.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an Institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
