**WITHDRAWAL ORDER**

AND WHEREAS, the recognition was granted to the institution namely Sri. Y.N. College of Elementary Education, No. 47, 7<sup>th</sup> Ward, Narasapur Village, Post and Taluk, West Godavari District-534275, Andhra Pradesh run by Sri Y.N. College Committee R.S No.47, Narasapur Village, Post and Taluk, West Godavari District-534275, Andhra Pradesh. The SRC vide order F.SRO/SRCAPP507/D.El.Ed/AP/2015/62234 dt.03.03.2015 for conducting D.El.Ed course of two-year duration with annual intake of 50 students.

2. AND WHEREAS, the institution vide letter dated 11.04.2016 request to return the FDR's submitted towards corpus fund and reserve fund for the sanction of D.El.Ed. Course. A letter was issued to the institution on 13.04.2016 regarding retiring of original FDR's Rs.7,00,000/- and 5,00,000/-. The institution vide letter dated 12.10.2020 submission of closing Institution.

3. AND WHEREAS, the matter was further considered by the SRC in its 390<sup>th</sup> meeting held on October 28-29, 2020 and the Committee decided as follows: -

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee decided to withdraw the recognition granted to Sri. Y.N. College of Elementary Education, No. 47, 7<sup>th</sup> Ward, Narasapur Village, Post and Taluk, West Godavari District-534275, Andhra Pradesh for conducting D.El.Ed course under clause 17(1) of NCTE Act, 1993 on its own request made vide letter dated 12.10.2020. However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director on the submission of the following:

- (a) NOC from the affiliating body.
- (b) NOC from the staff/faculty.
- (c) Resolution of the management to the effect for closure of the course.

4. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Sri. Y.N. College of Elementary Education, No. 47, 7<sup>th</sup> Ward, Narasapur Village, Post and Taluk, West Godavari District-534275, Andhra Pradesh run by Sri Y.N. College Committee R.S No.47, Narasapur Village, Post and Taluk, West Godavari District-534275, Andhra Pradesh for conducting D.El.Ed. course of two years duration with an annual intake of 50 students w.e.f. the next academic session.

5. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

**"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."**

6. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
