WHEREAS, the recognition was granted to the institution namely SSR College of Education for Women, Proddatur, Cuddapah District-516360, Andhra Pradesh run by SSR Educational Society, 3/899, Y.M.R. Colony, Proddatur, Cuddapah District-516361, Andhra Pradesh. The SRC vide order F.AP/NEW/SEC/82/SRO/NCTE/2002-2003/6155 dt.10.03.2003 for conducting (B.Ed.) course of two-year duration from the academic session 2002-03 with an annual intake of 100 students.

- AND WHEREAS, the Src in its 178th meeting held on 13-14 July 2009 and the Committee decided the institution was accorded recognition in the rented premises and not yet premises/building. In view of non-shifting to the permanent building and decided to issue Show Cause Notice u/s17 of NCTE Act and obtain shifting fees and other documents for causing inspection for shifting.
- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 21.01.2015. A Revised Provisional Recognition Order was issued to the institution on 11.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students (two units) from the academic session 2015-2016.
- AND WHEREAS, the SRC in its 314th meeting held on 27-28 May 2016 and the Committee decided as under: -
  - They have contested the shifting condition saying that they have all along been function in their own premises.
  - Land document shows their title to lands is entry earlier PAR to the effect they are function "a rented building".
- Ask them to show their title to the building. Accordingly, a Show Cause Notice was issued to the institution on 13.05.2019. The institution has not submitted any reply in response to the Show Cause Notice till date.
- AND WHEREAS, the matter was further considered by the SRC in its 392nd meeting held on December 15-16, 2020 and the Committee decided as follows: -

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

- 1. The management has not shifted its institution to its own permanent building which is in violation of the NCTE Regulations, 2002, 3(C).
- 2. The institution has also not responded to the Show Cause Notice issued on 13.05.2019.

Hence, the Committee decided to withdraw the recognition granted to SSR College of Education for Women, Proddatur, Cuddapah District-516360, Andhra Pradesh for conducting B.Ed course w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

- 6. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to SSR College of Education for Women, Proddatur, Cuddapah District-516360, Andhra Pradesh run by SSR Educational Society, 3/899, Y.M.R. Colony, Proddatur, Cuddapah District-516361, Andhra Pradesh for conducting B.Ed. course of two years duration with an annual intake of 100 students w.e.f. the next academic session.
- 7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: ~

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

**8.** Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="https://www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
