WITHDRAWAL ORDER**

**WHEREAS**, the recognition was granted to the institution namely **Aurora School of Education, Bhongir Revenue Division Bhongir, Nalgonda District – 508116, Telangana** run by **Aurora Educational Society, Chikkadapally, Hyderabad District – 500020, Telangana**. The SRC vide order **F.AP/SEC/NEW/272/NCTE/2002-2003/6650 dt.29.04.2003** for conducting **(B.Ed.)** course of two-year duration from the academic session 2002-03 with an annual intake of 100 students.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated **03.03.2014**. A Revised Provisional Recognition Order was issued to the institution on **11.05.2015** for conducting **B.Ed. course** of two years duration with an annual intake of **100 students (two units)** from the academic session 2015-2016.

3. **AND WHEREAS**, the institution has submitted its written representation on **30.07.2015** along with some relevant documents. The SRC in its **315<sup>th</sup>** meeting held on **17<sup>th</sup> – 18<sup>th</sup> June 2016** considered the matter and decided as under:-

1. *They have been running the course on lease land. They are entitled to continue there, for the full lease period of 32 years.*
  2. *They have given BP and EC. But, LUC and BCC are not given.*
  3. *Inspection fee has not been paid.*
  4. *Collect fee and cause inspection for B.Ed units under 2014 Regulations.*
  5. *Ask VT to collect all relevant documents.*
- As per the decision of SRC a letter was issued to the institution on **12.07.2016**.

4. **AND WHEREAS**, the matter was placed before the Southern Regional Committee in its **369<sup>th</sup>** meeting held on **28.01.2019**. The Committee decided to issue show cause notice to all such institutions which have not submitted compliance of the revised recognition order. Accordingly, as per the decision of SRC show cause notice was issued to the institution on **01.03.2018**. The institution has not submitted any reply to the show cause notice till date.

4. **AND WHEREAS**, the SRC in its **381<sup>st</sup>** meeting held on **31<sup>st</sup> Oct 01<sup>st</sup> Nov 2019** considered the matter and decided to issued FSCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents in response to RPRO issued by the SRC. Accordingly, a **Final Show Cause Notice** was issued on **14.11.2019**. The institution vide letter dated **02.12.2019** submitted reply to the Final Show Cause Notice.

5. **AND WHEREAS**, the matter was further considered by the SRC in its **392<sup>nd</sup>** meeting held on **December 15-16, 2020** and the Committee decided as follows: -

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

1. The management has not shifted its institution to its own permanent building which is in violation of the NCTE Regulations, 2002, 3(C).
2. The institution has submitted photocopy of building plan which is not approved by the competent authority.
3. The institution has not submitted Site Plan duly approved by the competent authority.
4. The institution has not submitted BCC duly approved by the competent authority.
5. The institution has not submitted list of faculty duly approved by the Registrar, of concerned affiliating university in prescribed format as directed by NCTE.

Hence, the Committee decided to **withdraw the recognition granted to Aurora School of Education, Bhongir Revenue Division Bhongir, Nalgonda District – 508116, Telangana** for conducting B.Ed course w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

6. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to **Aurora School of Education, Bhongir Revenue Division Bhongir, Nalgonda District – 508116, Telangana** run **Aurora Educational Society, Chikkadapally, Hyderabad District – 500020, Telangana** for conducting B.Ed. course of two years duration with an annual intake of 100 students w.e.f. the next academic session.

7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

**“If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government.”**

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through “online mode” available on NCTE’s website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE’s website.
