WITHDRAWAL ORDER**

WHEREAS, the recognition was granted to the institution namely **St. Lawrence College of Education, Arempula Village, Khammam Rural District – 507163, Telangana** run by **St. Lawrence Educational Society, 5-69 Beside Warangal Highway Arempula Khammam Rural, Telangana – 507163**. The SRC vide order F.AP/NEW/B.Ed/193/NCTE/2002-2003/7969 dt.03.07.2003 for conducting (B.Ed.) course of two-year duration from the academic session 2002-03 with an annual intake of 100 students.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 21.01.2015. A Revised Provisional Recognition Order was issued to the institution on 12.05.2015 for conducting **B.Ed. course** of two years duration with an annual intake of **100 students (two units)** from the academic session 2015-2016.

3. **AND WHEREAS**, the SRC in its 315th meeting held on 17th – 18th June 2016, considered the matter and decided as under:

1. They have shifted without NCTE approval.
2. Title deed is in order.
3. EC & LUC are in order.
4. BP and BCC are in order. Built-up area is adequate.
5. Original FDRs and latest Faculty list are not given.
6. Processing fee is only partly paid-Rs. 40,000/-
7. Collect the balance fee of Rs. 1,10,000/-- and cause inspection for shifting of B.Ed. (2 units).
8. Ask VT to collect all relevant documents; and, check in particular adequacy of built-up area to accommodate B.Ed. (2 units) of the 2014 pattern i.e., total intake of (100+100) =200

As per the decision of SRC, inspection intimation was sent to the institution and VT members on 03.08.2016. The inspection of the institution was conducted on 19.08.2016 and VT report along with Original D.D. of Rs. 1,10,000/- bearing no. 472060, documents and CD was received on 24.08.2016.

4. **AND WHEREAS**, the SRC in its 321st meeting held on 28th – 29th September 2016 considered the matter and decided to issue Show Cause Notice. Accordingly, a Show Cause Notice was issued to the institution on 24.10.2016.

5. **AND WHEREAS**, the SRC in its 381st meeting held on 31st Oct 01st Nov 2019 considered the matter and decided to issued SCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the

requisite documents in response to RPRO issued by the SRC. Accordingly, a **Final Show Cause Notice** was issued on **25.11.2019**.

6. **AND WHEREAS**, the institution vide letter dated 13.12.2019 & 29.02.2020 submitted reply to the Final Show Cause Notice.

7. **AND WHEREAS**, the matter was further considered by the SRC in its 392nd meeting held on December 15-16, 2020 and the Committee decided as follows: -

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

1. The management has not shifted its institution to its own permanent building which is in **violation of the NCTE Regulations, 2002, 3(C)**.
2. The institution has submitted building plan wherein the approving authority & Multipurpose hall is not legible.
3. The institution has not submitted Site Plan duly approved by the competent authority.
4. The institution has submitted the proforma of the staff which is not duly signed by the Registrar of concerned affiliating university. 2 Lecturer do not possess required minimum percentage of marks in Postgraduation which mandatory in NCTE Regulations, 2014.
5. The institution has submitted photocopy of FDRs which are already matured. The institution has not submitted the "Form A" issued by the respective Bank Manger towards creation of FDR of Rs.7 lakh and 5 lakh, totalling Rs.12 lakh towards Endowment Fund & Reserve Fund into joint account for a duration of 5 years along with a copy of the FDRs.

Hence, the Committee decided to **withdraw the recognition** granted to **St. Lawrence College of Education, Arempula Village, Khammam Rural District – 507163, Telangana** for conducting B.Ed course w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

8. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to **St. Lawrence College of Education, Arempula Village, Khammam Rural District – 507163, Telangana** run **St. Lawrence Educational Society, 5-69 Beside Warangal Highway Arempula Khammam Rural, Telangana – 507163** for conducting B.Ed. course of two years duration with an annual intake of 100 students w.e.f. the next academic session.

9. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

10. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
