WITHDRAWAL ORDER

WHEREAS, the recognition u/s 14 of NCTE Act, 1993 was granted to the institution namely **Hasanamba College of Education, Post Box No. 68, Vidyanagar, Hassan, Karnataka-573201** vide order F.KAR/B.Ed./56/SRO/NCTE/2000-2001/1039 dated 12.07.2000 for conducting **B.Ed. Course** of one-year duration with an annual intake of 100 students from the academic session 2000-2001.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution had submitted affidavit dated 20.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 16.05.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 (two basic unit) from the academic session 2015-16.

3. **AND WHEREAS**, a Corrigendum vide order no. F.SRO/NCTE/AOS00254/B.Ed./KA/2015/70371 dt. 21.07.2015 was issued to the institution on 21.07.2015 for conducting B.Ed. programme of two years duration with an annual intake of 50 students (one basic unit) from the academic session 2015-16.

4. **AND WHEREAS**, the SRC in its 369th Meeting held on 28.01.2019 has considered the matters and the Committee decided to issue Show Cause Notice in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents. Accordingly, as per decision of SRC a Show Cause Notice was issued to the institution on 12.02.2019. The institution has submitted reply on 13.03.2019.

5. **AND WHEREAS**, the SRC in its 405th Meeting held on 13th & 14th December, 2021 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC a Final Show Cause Notice was issued to the institution on 28.12.2021. The institution has submitted reply on 15.02.2022.

6. **AND WHEREAS**, the SRC in its 409th Meeting held on 29th -30th March 2022 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply on 15.02.2022. The Committee observed the reply submitted by the institution and found the following deficiencies.



1. *The institute submitted a proforma of 6 faculty signed by the Registrar, University of Mysore. The faculty strength is not enough for running B.Ed. course (1 unit) as per appendix 4 of NCTE Regulation, 2014. Further the date of approval of faculty proforma is not mentioned.*
2. *Building plan is neither approved nor legible.*
3. *As per BCC total built up area of the institute is only 11650.49 sq. ft. (1082.36 sq. mt.) which is not sufficient as per NCTE Regulations, 2014.*
4. *The website is still not complete with the information required under clauses 7 (14) (i), 8 (14) and 10 (3) of NCTE Regulations, 2014.*
5. *The institution did not submit proof of disbursement of salary to faculty & non-teaching staff through bank account as required under clause 10(2) of NCTE Regulations, 2014.*
6. *The institution did not submit documents related to management such as Registration Certificate, Bye laws etc.*

*Hence the recognition granted to **Hasanamba College of Education, Post Box No. 68, Vidyanagar, Hassan, Karnataka-573201** for B.Ed. Course is withdrawn under Section 17(1) of NCTE Act, 1993 from the next academic session i.e. **2022-2023**. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the next academic session stands withdrawn. Hence, the institution is not entitled to participate in counseling / making admissions from the next academic session i.e. **2022-2023**."*

7. NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of **Hasanamba College of Education, Post Box No. 68, Vidyanagar, Hassan, Karnataka-573201** for conducting B.Ed. programme of two year duration with an annual intake of 50 students (one basic unit) for B.Ed. course with effect from the academic session i.e. 2022-2023 onwards. Further, on withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the academic session stands withdrawn. Hence, the institution is not entitled to participate in counseling / making admissions from the academic session i.e. **2022-2023**.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
