WHEREAS, the recognition u/s 14 of NCTE Act. 1993 was granted to the institution namely Smt. Vimala Yellurkar Teacher Training Institute, 1st Cross, Krishna Colony, Rani Channammanagar, Belgum-590006, Karnataka run by Jana Seva Shikshan Mandal, Rangubai Palace, Belgume-590002, Karnataka vide order No F.SRO/NCTE/D.Ed/2005-2006/4885 dated 22.12.2005 for Elementary D.Ed. Course of two and half years duration with an annual intake of 50 students from academic session 2005-2006.

2. AND WHEREAS, the Principal/DDPI(Dev), DIET, Belagavi vide letter No. S3/Pry Ded.College./2021.22/947 dt. 09.03.2022 vide which the following enrollment details were furnished:-

Further, the Principal/DDPI(Dev), DIET, Belagavi vide the aforementioned letter informed that the college has been served repeated notices to adhere to NCTE Norms or else give proposal for closure of institution but till today they have not responded. Hence the Principal, DIET requested NCTE to take action against the concerned college.

3. AND WHEREAS, the SRC in its 409<sup>th</sup> Meeting held on 29<sup>th</sup> -30<sup>th</sup> March 20222 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee agreed to close down the institution as requested by the Principal/DDPI(Dev), DIET, Belagavi vide letter No. S3/Pry Ded.College./2021.22/947 dt. 09.03.2022 by withdrawing the recognition granted to Smt. Vimala Yellurkar Teacher Training Institute, 1st Cross, Krishna Colony, Rani Channammanagar, Belgum-590006, Karnataka for conducting D.Ed. Programme under clause 17(1) of NCTE Act, 1993 from the academic session 2022-2023.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC in this meeting."

4. NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Smt. Vimala Yellurkar Teacher Training Institute, 1<sup>st</sup> Cross, Krishna Colony, Rani Channammanagar, Belgum-590006, Karnataka run by Jana Seva Shikshan Mandal, Rangubai Palace, Belgume-590002, Karnataka for D.Ed. course of two and half years duration with an annual intake of 50 students with effect from the academic session i.e. 2022-2033 onwards.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
