WITHDRAWAL ORDER

WHEREAS, the recognition u/s 15 of NCTE Act, 1993 was granted to the institution namely, **K.C.T. D.Ed. Institute, Post Box No. 104, KCT Campus, Qamarul Islam Colony, Rosa, Gulbarga-585104, Karnataka** run by **H.S.M.A. Kallerawan Charitable Trust, Gulbarga, Karnataka** vide order no. F.SRO/NCTE/D.Ed./2004-2005/8726 dated 29.11.2004 for conducting Elementary (D.Ed.) course of two and half years duration with an annual intake of 50 students.

2. **AND WHEREAS**, the SRC in its 402nd meeting held on 13th – 14th September, 2021 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 07.10.2021. The institution did not submit reply to the Final Show Cause Notice.

3. **AND WHEREAS**, the SRC in its 409th meeting held on 29th – 30th March, 2022 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution has mentioned that due to scarcity of admissions D.Ed. course is not running from 2015-2016 onwards.

Hence the recognition granted to K.C.T. D.Ed. Institute, Post Box-104, K.C.T. Campus, Qamarul Islam Colony, Rosa, Gulbarga-585104, Karnataka for D.Ed. course is withdrawn under Section 17(1) of NCTE Act, 1993 from the next academic session i.e. 2022-2023. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the next academic session stands withdrawn. Hence, the institution is not entitled to participate in counseling / making admissions from the next academic session i.e. 2022-2023."

4. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to **K.C.T. D.Ed. Institute, Post Box No. 104, KCT Campus, Qamarul Islam Colony, Rosa, Gulbarga-585104, Karnataka** for conducting Elementary D.Ed. programme of two and half years duration with an annual intake of 50 students (1 basic unit) with effect from the academic session i.e., 2022-2023 onwards.

5. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

6. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
