**WITHDRAWAL ORDER**

**WHEREAS**, the recognition u/s 14 of NCTE Act. 1993 was granted to the institution namely **Institute of Advanced Study in Education (IASE), Kakatiya University, Vidyaranyaपुरी, Warangal-506009 Telangana** vide order dated 18.10.2002 for conducting M.Ed. course of one-year duration with an annual intake of 25 students.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dated 19.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 31.05.2015 for conducting M.Ed. course of two years duration with an annual intake of 50 (one basic unit) from the academic session 2015-16.

3. **AND WHEREAS**, the SRC in its 381<sup>st</sup> Meeting held on 31<sup>st</sup> October & 01<sup>st</sup> November, 2019 decided to issue SCN in all such matters where the institution has not submitted the requisite documents/VT report accompanied with the requisite documents. Accordingly, a First Show Cause Notice was issued to the institution on 25.11.2019.

4. **AND WHEREAS**, the SRC in its 378<sup>th</sup> meeting held on 25<sup>th</sup> – 26<sup>th</sup> July, 2019 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC a Final Show Cause Notice was issued to the institution on 05.08.2019. The institution has submitted reply on 11.09.2019.

5. **AND WHEREAS**, the SRC in its 402<sup>nd</sup> Meeting held on 13<sup>th</sup> -14<sup>th</sup> September 2021 considered the matter and decided issue last reminder letter. Accordingly, as per decision of SRC a last reminder letter was issued to the institution on 07.10.2021. The institution has not submitted reply to the last reminder letter.

6. **AND WHEREAS**, the SRC in its 409<sup>th</sup> Meeting held on 29<sup>th</sup> – 30<sup>th</sup> March 2022 considered the matter and decided as under:-

*"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-*

*The institution was issued a Last Reminder Letter on 07.10.2021. The institution failed to submit reply to the Last Reminder Letter.*

*Hence the recognition granted to Institute of Advanced Study in Education (IASE), Kakatiya University, Vidyaranyaपुरी, Warangal-506009 Telangana for M.Ed. course is withdrawn under Section 17(1) of NCTE Act, 1993 from the next academic session i.e. 2022-*



**2023. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the next academic session stands withdrawn. Hence, the institution is not entitled to participate in counseling / making admissions from the next academic session i.e. 2022-2023."**

**7. NOW, THEREFORE,** in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of **Institute of Advanced Study in Education (IASE), Kakatiya University, Vidyananyapuri, Warangal-506009 Telangana** for conducting **M.Ed.** programme of two-year duration with an annual intake of 50 students (one basic unit) for M.Ed. Programme with effect from the academic session i.e. 2022-2023 onwards. further on withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the academic session stands withdrawn. Hence, the institution is not entitled to participate in counseling / making admissions from the academic session i.e. **2022-2023.**

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

**"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."**

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
