WHEREAS, the recognition u/s 14 of NCTE Act. 1993 was granted to the institution namely G.T.P. College of Education, Dirusumarru Road, Bhimavaram-534202, Andhra Pradesh vide order no. F.AP/M.Ed/SRO/NCTE/2004-2005/6019 dated 12.08.2004 for starting M.Ed. course of one-year duration from the academic session 2004-2005 with an annual intake of 25 students.

AND WHEREAS, the enhancement of intake of 10 seats from existing 25 to 35 is permitted to G.T.P. College of Education, Dirusumarru Road, Bhimavaram-534202, Andhra Pradesh vide order No. F.SRO/NCTE/2010-2011/20673 dated 25.08.2010 from the session 2010-2011

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution had submitted affidavit dated 19.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 26.05.2015 for conducting M.Ed. course of two years duration with an annual intake of 50 (One basic unit) from the academic session 2015-16.

AND WHEREAS, the SRC in its 369th Meeting held on 28.01.2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted requisite documents/VT report accompanied with requisite documents in responds to RPRO issued by the SRC. Accordingly, a Show Cause Notice was issued to the institution on 27.03.2019. The institution has not submitted reply to the Show Cause Notice.

AND WHEREAS, the SRC in its meeting 406th held on 19th January, 2022 considered the matter and decided to issue Final Show Case Notice. Accordingly, as per decision of SRC a Final Show Cause Notice was issued to the institution on 04.02.2022. The institution has submitted reply on 09.03.2022.

AND WHEREAS, the SRC in its 409th Meeting held on 29th -30th March 20222 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

1. The institution failed in submission of latest approval of faculty issued by the affiliating body for M.Ed. course.

Hence the recognition granted to GTP College of Education for Women, Dirusumarru Road, Bhimavaram-534201, West Godavari, Andhra Pradesh for M.Ed. course is withdrawn under Section 17(1) of NCTE Act, 1993 from the next academic session i.e. 2022-2023. On withdrawal of recognition, the affiliation if any granted under Clause 8(10)

of NCTE Regulation, 2014 by the concerned affiliating body from the next academic session stands withdrawn. Hence, the institution is not entitled to participate in counseling / making admissions from the next academic session i.e. 2022-2023."

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of GTP College of Education for Women, Dirusumarru Road, Bhimavaram-534201, West Godavari, Andhra Pradesh for conducting M.Ed. Programme of two years duration with an annual intake of 50 for One basic unit of 50 students with effect from the academic session i.e. 2022-2023 onwards. Further, on withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the academic session stands withdrawn. Hence, the institution is not entitled to participate for counselling from the academic session i.e. 2022-2023 and the institution is also not permitted to take any fresh admission of students from the academic session 2022-2023.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
