WHEREAS, recognition u/s 14 Act of NCTE, 1993 was granted to the institution namely, V.R. College of Education, G.T. Road, Nellore, Andhra Pradesh-524001 run by V.R. College and High School Committee, Nellore District, Andhra Pradesh vide SRC vide order no. F.SRO/NCTE/B.Ed./2006-2007/2143 dt. 30.04.2007 for conducting Secondary (B.Ed.) course of one-year duration with an annual intake of 100 students.

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has 2. submitted affidavit dated 09.02.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 06.05.2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 students for two basic units from the academic session 2015-16.
- AND WHEREAS, a Corrigendum was issued to the institution vide Order No. F.No.SRO/NCTE/APS07022/B.Ed./AP/2015/72234 on **04.08.2015** for reduction of intake from 2 units to 1 unit as the affidavit submitted was for one unit.
- AND WHEREAS, the SRC in its 381st meeting held on 31st Oct & 01st Nov. 2019 considered the matter and decided to issue SCN/FSCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents. The institution has submitted reply on 30.11.2019 & 13.01.2020.
- AND WHEREAS, the SRC in its 394th meeting held on 27th 28th January, 2021 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 04.03.2021. The institution has submitted reply on 19.03.2021.
- AND WHEREAS, the SRC in its 409th Meeting held on 29th & 30th March, 2022 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply on 19.03.2021. The Committee observed the reply submitted by the institution and found the following deficiencies.

- 1. The institution has submitted land documents but not readable and did not submit certified/Notarized copy land documents.
- 2. The survey number mentioned in LUC is different as mentioned in NEC.
- 3. The institution has submitted building plan, but the total built up and size of Multipurpose Hall are not mentioned. Further, the building plan is also not approved by the competent authority.

- 4. BCC submitted by the institution is not under prescribed format.
- 5. Faculty list duly approved by the affiliating body has not been submitted by the institution.
- 6. The institution failed in submission of "Form A" issued by the respective bank.

Hence the recognition granted to **V.R. College of Education, G.T. Road, Nellore-524001, Andhra Pradesh** for **B.Ed. course** is withdrawn under Section 17(1) of NCTE Act, 1993 from the next academic session i.e., **2022-2023**. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the next academic session stands withdrawn. Hence, the institution is not entitled to participate in counselling / making admissions from the next academic session i.e., **2022-2023**."

- 7. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to V.R. College of Education, Trunk Road, Nellore, Andhra Pradesh-524001 run by V.R. College and High School Committee, Trunk Road, Nellore, Andhra Pradesh-524001 for conducting B.Ed. programme of two years duration with an annual intake of 50 students (1 basic unit) with effect from the academic session i.e., 2022-2023 onwards. Further, on withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the academic session stands withdrawn. Hence, the institution is not entitled to participate for counselling from the academic session i.e., 2022-2023 and the institution is also not permitted to take any fresh admission of students from the academic session 2022-2023.
- 8. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
