CONTINUATION ORDER

WHEREAS, recognition u/s 14 Act of NCTE, 1993 to the institution namely **Mar Theophilus Training College, Nalamchira, Tiruvananthapuram, Kerala** vide order no. F./SRO/NCTE/98-99/550 on 19.06.1998 accorded one year provisional recognition for Secondary course with duration of one year for the year 1998-1999.

2. **AND WHEREAS**, a Conditional Recognition was granted to **Mar Theophilus Training College, Bethany Hills, Nalamchira, Tiruvananthapuram-695015, Kerala** for conducting **B.Ed.** course of one-year duration vide SRC (NCTE) order No. F./SRO/NCTE/98-2000/8653 dated 09.06.1999. In response, the institution has not submitted its compliance report against conditional recognition order.

3. **AND WHEREAS**, a letter No. F.SRO/NCTE/2009-2010/14443 dated 06.07.2009 regarding the Recognition order No. F.SRO/NCTE/2000-01/5178 dated 30.06.2000 was granted to **Mar Theophilus Training College, Bethany Hills, Nalamchira, Tiruvananthapuram-695015, Kerala** for **B.Ed.** course for an intake of 150 students.

4. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit on 17.01.2015 for its willingness of two units in **B.Ed.** course and adherence of provisions of new Regulations. Thereafter, a Revised Provisional Recognition Order was issued to the institution on 13.05.2015 for conducting **B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.**

5. **AND WHEREAS**, a corrigendum issued to the institution vide order No. F.SRO/NCTE/AOS00357/B.Ed./KL/2015/72239 dated 04.08.2015 for conducting **B.Ed.** programme of two years duration with an annual intake of 50 for one basic unit from the academic session 2015-16.

6. **AND WHEREAS**, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, Show Cause Notice issued on 17.07.2019.

7. **AND WHEREAS**, the institution submitted written representation on 08.08.2019 stating that *"we are preparing all the required documents as a single lot to forward to you. A few days will take for the translation of documents in regional language"*.

8. **AND WHEREAS**, a letter by mail vide No.283(a)/MSC-MTTC/2019 dated 26.08.2019 was received from the institution requesting to permit the college to provisionally admit the students from 2019-20 academic year. Hence, the govt. of Kerala permitted the college

to admit one more batch to the college from 2019-20 onwards so that the NCTE sanctioned strength would be realized.

9. **AND WHEREAS**, the SRC in its 393rd meeting held on 05th – 06th January, 2021 has considered the matter and decided to constitute VT. As per the direction of SRC, the inspection was conducted on 25th – 26th April, 2022 and the VT Report received in the office of SRC on 04.05.2022.

10. **AND WHEREAS**, the SRC in its 413th Meeting held on 22nd & 23rd August, 2022 reconsidered the decision taken on 412th Meeting held on 05th & 06th July, 2022 and decided as under: -

“The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made were made: -

The Committee on the perusal of the VT report decided that the continuation order be issued to the Institution Mar Theophilus Training College, Resurvey No. 215/8, Survey No. 215, Part-8, Block No. 14887, Ulloor Panchayat, Tiruvananthapuram-695015, Kerala for B.Ed. programme for 1 basic unit of 50 students from the session 2022-23.”

11. **NOW THEREFORE**, this order is issued permitting the institution i.e., **Mar Theophilus Training College, Resurvey No. 215/8, Survey No. 215, Part-8, Block No. 14887, Ulloor Panchayat, Tiruvananthapuram-695015, Kerala** run by **The Malankara Syrian Catholic Colleges Association of Archdiocese of Trivandrum, Samanwaya Pastoral Centre, Patton, Trivandrum, Kerala-695004** for Continuation of recognition for **B.Ed. programme** for two years duration with an annual intake of **1 basic unit of 50 student** subject to fulfilment of the following conditions: -

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

12. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

13. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

14. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- e. Fee charged from students.
- f. Available infrastructural facilities.
- g. Facilities added during the last quarter.
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

15. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

16. The institution shall make available the list of students admitted on its official website.

17. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
