- 3. AND WHEREAS, the SRC in its 412th meeting held on 05th 06th July, 2022 has considered the matter and decided to issue Final Show Cause Notice to the institution. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 26.07.2022. The institution has submitted reply on 27.07.2022.
- 4. AND WHEREAS, the SRC in its 413th Meeting held on 22nd & 23rd August, 2022 considered the matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Deekshitha B.Ed. College, Survey No. 550, 551, 555A, Sajjaladinne Village, Tadipatri Mandal-515411, Anantapuramu District, Andhra Pradesh for B.Ed. programme for 2 basic units of 50 students each."

- 5. NOW THEREFORE, this order is issued permitting the institution i.e., Deekshitha B.Ed. College, Survey No. 550, 551, 555A, Sajjaladinne Village, Tadipatri Mandal-515411, Anantapuramu District, Andhra Pradesh run by Deekshitha Educational Development Society, Plot no. 550, Sajjaladinne Village, Tadipatri Mandal-515411, Anantapuramu District, Andhra Pradesh for Continuation of recognition for B.Ed. programme for two years duration with an annual intake of 2 basic units of 50 students each subject to fulfilment of the following conditions:-
