The decision of SRC taken in 400th meeting held on 13th - 14th July 2021, of order no. F. No. F.SRO/NCTE/APS02507 /B.Ed./KA/2021/127823-7830 dated 29.07.2021 has been reviewed in its 403rd meeting held on 18th - 19th October, 2021 and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

In compliance of order dated 08.10.2021 passed by Hon'ble High Court of Delhi in writ petition no. 11591/2021 titled as KLE Society college of Education Versus National Council for Teacher Education and another, the institution will be entitled to participate in the counselling for the academic session 2021-2022. The Committee further decided to upload the website of SRC accordingly. The Committee further decided to communicate the recognition status of the petitioner to the Affiliating University and the State Government however the withdrawal of the recognition to KLE Society College of Education stands effective from the academic session 2022-23.

Accordingly, RD, SRC is advised to issue modified orders / corrigendum to withdrawal orders be issued."

NOW THEREFORE, the decision in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, may be read as the Southern Regional Committee hereby withdraws recognition granted to K.L.E. Society's College of Education, Shedgeri, Near Sundaranarayana Temple Road, Ankola, Uttara Kananada District, Karnataka-581314 run by K.L.E. Society, Belgaum, Karnataka for conducting B.Ed. programme of two years duration with an annual intake of 100 students (2 basic units) w.e.f. the academic session i.e., 2022-2023 onwards.

Other contents of order No. F. No. F.SRO/NCTE/APS02507 /B.Ed./KA/2021/127823-7830 dated 29.07.2021 shall remain unchanged.
