WHEREAS, the recognition was granted to the institution namely, Lavanya College of Education, Ramananda Ashrama, Doddaballapura, Bangalore Rural District, Karnataka-561203 run by Lavanya Education Society, Doddaballapur, Bangalore Rural District. Karnataka vide SRC order No. F. SRO/NCTE/B.Ed./2004-2005/8913 on 30.11,2004 for conducting Secondary (B.Ed.) course of one-year duration with an annual intake of 100 students from the academic session 2004-2005.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 12.02.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 16.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.
- 3. AND WHEREAS, the SRC in its 322nd meeting held on 20th - 21st October, 2016 considered the request for reduction of intake of from 2 units to one unit matter decided to issue a letter. Accordingly, as per the decision of SRC a letter was issued to the institution on 16.11.2016.
- AND WHEREAS, the SRC in its 369th meeting held on 28th January 2019 considered 4. the matter and decided to issue Show Cause Notice. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 08.02.2019. The institution has submitted reply on 05.03.2019.
- AND WHEREAS, the SRC in its 375th meeting held on 13th & 14th May 2019 considered the matter and decided to issue Show Cause Notice to the institution. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 23.05.2019. The institution has submitted reply on 12.06.2019.
- AND WHEREAS, the SRC in its 386th meeting held on 23rd & 24th July 2020 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 05.08.2020. The institution has submitted reply on 07.09.2020.
- AND WHEREAS, the SRC in its 389th meeting held on 12th 14th October 2020 considered the matter and decided to withdraw the recognition. Accordingly, as per decision of SRC vide order no. F.SRO/NCTE/APSO2393/KA/B.Ed./2020/119317-9323 dated 16.10.2020 withdrawal order was issued to the institution.
- AND WHEREAS, the direction of the Hon'ble High Court of Karnataka Writ Petition No. 14915//2020 dated 16.12.2020 after hearing the Court made. The institution has submitted reply on 07.09.2021.

9. **AND WHEREAS**, the SRC in its 402nd Meeting held on 13th & 14th September, 2021 considered the matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Lavanya College of Education, Survey No.19/1B, 19/2, Ward No.4 Gangadharapura, Municipality, Ramananda Ashrama, Doddaballapura, Bangalore Rural District-561203, Karnataka for B.Ed. programme for 1 basic unit of 50 students.

The request of the institution for allowing additional intake is not accepted by the SRC, NCTE."

- 10. NOW THEREFORE, this order is issued permitting the institution i.e., Lavanya College of Education, Survey No.19/1B, 19/2, Ward No.4 Gangadharapura, Municipality, Ramananda Ashrama, Doddaballapura, Bangalore Rural District-561203, Karnataka run by Lavanya College of Education, Survey No.19/1B, 19/2, Ward No.4 Gangadharapura, Municipality, Ramananda Ashrama, Doddaballapura, Bangalore Rural District-561203, Karnataka for Continuation of recognition for B.Ed. programme for two years duration with an annual intake of 1 basic unit of 50 students subject to fulfilment of the following conditions:
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 11. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 12. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 13. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building,

office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.

- e. Fee charged from students.
- f. Available infrastructural facilities.
- g. Facilities added during the last quarter.
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 14. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 15. The institution shall make available the list of students admitted on its official website.
- 16. The institution shall fill the information on GIS Portal on the NCTE Website.
