WHEREAS, the recognition was granted to the institution namely Sri Venkateswara Collegeof Education, Sri Venkateswara Junior and Degree College, Kondamallepally, Devarkonda Mandal, Nalgonda District, Andhra Pradesh vide SRC (NCTE) order no. F.AP/SEC/N/SRO/NCTE/2005-2006/5607 dt. 09.03.2006 for conducting Secondary (B.Ed.) course of one year duration with an annual intake of 100 students from the academic session 2005-2006.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 19.01.2015 for its willingness for adherence of provisions of new Regulations. A Revised Provisional Recognition Order was issued to the institution on dt. 11.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-16.
- **3. AND WHEREAS,** the SRC in its 369th meeting held on 28.01.2019 considered the matter and decided to issue show cause notice to all such institutions which have not submitted compliance of the revised recognition order. Accordingly, as per the decision of SRC a show cause notice was issued to the institution on 13.03.2019. The institution has submitted reply received on 22.04.2019.
- **4. AND WHEREAS,** the SRC in its 381^{st} meeting held on 31^{st} Oct -01^{st} Nov, 2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents in response to RPRO issued by the SRC. Accordingly, as per the decision of SRC Final Show Cause Notice was issued to the institution on 21.11.2019. The institution vide letter dated 14.12.2019 submitted reply to the Final Show Cause Notice.
- **5. AND WHEREAS,** the SRC in its 385th meeting held on 03rd March, 2020 considered the matter and decided constitute VT. The institution conduct on 27.01.2021 and VT report received on 02.02.2021. The institution has submitted reply on 27.08.2021.
- **6. AND WHEREAS**, the SRC in its 402nd Meeting held on 13th & 14th September, 2021 considered the matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee on perusal of the reply submitted by the institution namely Sri Venkateswara College of Education decided that shifting of premises be permitted to the institution at new address i.e. Survey No. 112, Konda M

Mallepally Village & Mandal, Nalgonda District-508243, Telangana. The Committee also decided that continuation order be issued to the Institution for B.Ed. programme for 2 basic units of 50 students each."

- 7. NOW THEREFORE, the SRC decided that shifting of premises be permitted to the institution Venkateswara College of Education, Survey No. 30 & 31 Chinna Adiserlapally Village, Sagar Road, Konda Mallelpally Post & Mandal, Devarkonda, Nalgonda District 508243, Telangana at new address i.e., Survey no. 112, Konda Mallepally Village & Mandal, Nalgonda District, Telangana-508243 and also decided for continuation of recognition for B.Ed. programme for two year duration with an annual intake of (2 basic units) of 50 students each subject to fulfilment of the following conditions:
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 8. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.
- The institution shall submit to the Regional Committee a Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 10. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
 - e. Fee charged from students.
 - f. Available infrastructural facilities.
 - g. Facilities added during the last quarter.

- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 11. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 12. The institution shall make available the list of students admitted on its official website.
- 13. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
