CONTINUATION ORDER

WHEREAS, the recognition was granted to the institution namely, Thellar College of Education, Tindivanam Road, Thellar, Vandavasi Taluk, Thiruvannamalai District, Tamilnadu-604406 run by Arulmigu Sri Mathalamman Educational Trust, Thiruvannamalai District, Tamilnadu vide SRC (NCTE) order no. F.SRO.NCTE/B.Ed./2006-2007/9704 dt. 23.12,2006 for Secondary (B.Ed.) course of one-year duration with an annual intake of 100 students.

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 19.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 26,05,2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-16 along with permission to shift its premises to the new location/building at Thellar College of Education, No. 617/2, 3, Tindivanam Road, Thellar. Vandavasi Taluk, Thiruvannamalai, District-604406, Tamilnadu.
- AND WHEREAS, on the basis of request, the SRC in its 343rd meeting held on 1st & 02nd August, 2017 decided for reduction of intake form 2 units to 1 unit. Accordingly, an vide order no. F.No.SRO/NCTE/APS04850/B.Ed./TN/2017-18/95161 dt. 04.10.2017 was issued the institution for reduction of intake from 2 units to 1 unit.
- AND WHEREAS, the SRC in its 369th Meeting held on 28th January 2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT Repost accompanied with requisite documents in respond to RPRO issued by the SRC. Accordingly, as per decision of SRC Show Cause was issued to the institution on 20.08.2019. The institution has submitted reply on 11.09.2019.
- AND WHEREAS, the SRC in its 384th meeting held 12th 13th February, 2020 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC Final Show Cause Notice was issued to the institution on 27.02.2020. The institution has submitted reply on 23.09.2020 & 09.02.2021.
- AND WHEREAS, the SRC in its 395th meeting held on 25th 26th February, 2021 considered the matter and decided to withdraw the recognition. Accordingly, as per decision of SRC a Withdrawal Order no. F.SRO/NCTE/ APSO4850/B,Ed./TN/2021/25185-5192 dated 16.03.2021 was issued to the institution.
- AND WHEREAS, aggrieved by the order of the SRC, the institution preferred an Appeal 7. before the Appellate Authority of the NCTE. The Appellate Authority vide order no. F.No.89-145/E-184366/2021 Appeal/16th Mtg.-2021/29th 2021/100577 dated 07.07.2021 appeal remand back the order appealed against. The institution vide letter dated 01.09.2021 submitted reply to the appeal remand back order.

8. AND WHEREAS, the SRC in its 402nd Meeting held on 13th & 14th September, 2021 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Thellar College of Education, Survey No.617/2, 617/3, Thellar Village, Vandavasi Taluk, Thiruvannamalai District-604406, Tamilnadu for B.Ed. programme for 1 basic unit of 50 students."

- 9. NOW THEREFORE, this order is issued permitting the institution i.e., Thellar College of Education, Survey No.617/2, 617/3, Thellar Village, Vandavasi Taluk, Thiruvannamalai District-604406, Tamilnadu run by Arulmigu Sri Mathalamman Educational Trust, Thiruvannamalai District, Tamilnadu-604406 for Continuation of recognition for B.Ed. programme for two-year duration with annual intake of 1 basic unit of 50 students subject to fulfilment of the following conditions:
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- **10.** Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 11. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 12. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 13. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 14. The institution shall make available the list of students admitted on its official website.
- 15. The institution shall fill the information on GIS Portal on the NCTE Website.
