WHEREAS, the recognition was granted to the institution namely Kingston College of Education, Siddipet Revenue Disvision, Ponnala village, Siddipet Mandal Medak District, Telangana run by Kingston Educational Society, Pratapnagar, Musaram Bagh, The SRC Hyderabad, Telangana. Dilsukhnagar. F.AP/NEW/B.Ed/286/SRO/NCTE/2002-2003/6670 dt.08.04.2003 for conducting (B.Ed.) course of two-year duration from the academic session 2002-03 with an annual intake of 100 students.

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 22.01.2015.
- AND WHEREAS, a Revised Provisional Recognition Order was issued to the institution on 11.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students (two units) from the academic session 2015-2016.
- AND WHEREAS, the SRC issued a Corrigendum vide F.SRO/NCTE/APSO0320/B.Ed/AP/2015/69049 to the institution on 01.07.2015 one basic
- AND WHEREAS, the institution VT conducted on 18.08.2016 and the VT report was received in the office on 29.08.2016 along with documents. The SRC in its 321st meeting held on 28th - 29th September 2016 considered the VT report and decided to issue Show Cause Notice. Accordingly, as per the decision of SRC Show Cause Notice was issued to the institution on 26.10.2016
- AND WHEREAS, the SRC in its 381st meeting held on 31st Oct 01st Nov 2019 considered the matter and decided to issued SCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents in response to RPRO issued by the SRC. Accordingly, a First Show Cause Notice was issued on 19.11.2019. The institution has not submitted any reply to the First Show Cause Notice till date.
- AND WHEREAS, the matter was further considered by the SRC in its 392nd meeting .7. held on December 15-16, 2020 and the Committee decided as follows: -

The original files of the Institution along with other related documents, NCTE Act. 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

1. The management has not shifted its institution to its own permanent building which is in violation of the NCTE Regulations, 2002, 3(C).

Hence, the Committee decided to withdraw the recognition granted to Kingston College of Education, Siddipet Revenue Disvision, Ponnala village, Siddipet Mandal Medak District, Telangana for conducting B.Ed course w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

- 8. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Kingston College of Education, Siddipet Revenue Disvision, Ponnala village, Siddipet Mandal Medak District, Telangana run by Kingston Educational Society, Pratapnagar, Musaram Bagh, Dilsukhnagar, Hyderabad, Telangana for conducting B.Ed. course of two years duration with an annual intake of 50 students wielf, the next academic session.
- 9. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

10. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
