WHEREAS, the recognition was granted to the institution namely Madhava Institute of Advanced Study in Education, Bhongir Revenue Division, Bhongir, Nalgonda District - 508116, Andhra Pradesh run by Maabhoomi Centre for Urban & Rural Enlishtenment, Munagala, order SRC (NCTE) vide Pradesh **Andhra** Nalgonda District. F.AP/NEW/B.Ed/237/SRO/NCTE/2002-2003/6132 dt 28.02.2003 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt. 04.02.2015 for its willingness for adherence of provisions of new Regulations.

AND WHEREAS, the matter was placed before the Sothern Regional Committee in its 369th meeting held on 28.01.2019. The Committee decided to issue show cause notice to all such institutions which have not submitted compliance of the revised recognition order. Accordingly, as per the decision of SRC show cause notice was issued to the institution on 26.02.2019. The institution has not submitted any reply to the Show Cause Notice.

AND WHEREAS, the SRC in its 392nd Meeting held on 15th & 16th December, 2020 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee noted that the institution has failed to submit reply / written representation in respect to the Final Show Cause Notice dt 26.02.2019 issued to the institution.

Hence, the Committee decided to withdraw the recognition granted to Madhava Institute of Advanced Study in Education, Bhongir Revenue Division, Bhongir, Nalgonda District -508116, Telangana for conducting B.Ed, course w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Madhava Institute of Advanced Study in Education, Bhongir Revenue Division, Bhongir, Nalgonda District - 508116, Telangana

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order.
