WHEREAS, the recognition was granted to the institution namely Chaitanya College of Education, Markapur Revenue Division Markapur, Prakasam District-523316, Andhra Pradesh run by Chaitanya Educational Society, Jawahar Nagar Colony, Markapur-523316, Prakasam Dist., Andhra Pradesh vide SRC (NCTE) order no. F.AP/NEW/B.ED./158/SRO/NCTE/2002-2003/6103 dt 28.02.2003 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

AND WHEREAS, the SRC in its 212<sup>th</sup> Meeting held on 24<sup>th</sup> Oct 2011 and the Committee considered all the relevant documentary evidences and it was decided to issue Show Cause Notice to B.Ed. Course. Accordingly, a Show Cause Notice was issued to the institution on 05.12.2011.

AND WHEREAS, An affidavit dated 07.12.2005 for the expansion activities of the name of the Society" Janke Rami Reddy Memorial Education Society" has been changed as "Chaitanya Educational Society.

"A letter dated 23.12.2016 regarding Clarification to change of Management on the subject mentioned above and to say that, Para12 of the guideline dated 24.12.2014 issued by NCTE Hqr. Is related to the request, received for change in the name of Institution. Fee in such cases be charged only if an inspection is required to be conducted (at the existing rate of Rs. 1.50 lakhs).

However, in view of lack of nay specific provision in the regulations, about change in the Management, no request needs to be considered, where a Society/Trust/Company, as it would amount to commercialization of teacher education."

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt. 18.01.2015 for its willingness for adherence of provisions of new Regulations.

AND WHEREAS, a revised provisional recognition order was issued to the institution on 11.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.

AND WHEREAS, the SRC in its meeting held on 22<sup>nd</sup> Oct 2019 and the Sub-Committee noted that institutions have not submitted requisite documents or only part reply has been submitted. The Sub-Committee decided to issue Show Cause Notice. Accordingly, a First Show Cause Notice was issued to the institution on 24.10.2019. The institution vide dated 14.11.2019 submitted reply in response to the First Show Cause Notice.

AND WHEREAS, the SRC in its 392<sup>nd</sup> Meeting held on 15<sup>th</sup> & 16<sup>th</sup> December, 2020 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee noted that the institution has failed to submit reply / written representation in respect to the **Final Show Cause Notice** dt 03.11.2020 issued to the institution.

Hence, the Committee decided to withdraw the recognition granted to Chaitanya College of Education, Markapur Revenue Division Markapur, Prakasam District-523316, Andhra Pradesh for conducting B.Ed, course w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Chaitanya College of Education, Markapur Revenue Division Markapur, Prakasam District-523316, Andhra Pradesh for conducting B.Ed. programme of two year duration with an annual intake of 100 students (2 units) w.e.f. the next academic session.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="https://www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
