WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the institution namely Thandrapaparaya College of Education, Near Railway Gate, JKR Buildings, Bobbili-535558, Vizianagaram District, Andhra Pradesh run by Sri Lokabandu Educational Society, Vizianagaram District, Andhra Pradesh. The SRC vide order F/AP/B.Ed/07/SRO/NCTE/2000-2001/1950 dt.07.09.2000 for conducting (B.Ed.) course of two-year duration from the academic session 2000-01 with an annual intake of 100 students.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 12.01.2015. A Revised Provisional Recognition Order was issued to the institution on 12.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students (two units) from the academic session 2015-2016.
- 3. AND WHEREAS, as per decision of SRC, reduction from 2 units to 1-unit order was issued to the institution on 08.08.2017.
- 4. AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, Show Cause Notice issued on 18.02.2019. The institutions vide letter dated 21.11.2019 submitted reply to the Final Show Cause Notice.
- 5. AND WHEREAS, the matter was further considered by the SRC in its 392nd meeting held on December 15-16, 2020 and the Committee decided as follows: -

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee noted the reply submitted by the institution on 28.09.2020 in respect to the Last reminder letter, and the Committee made following observations: -

i. A letter regarding approval of faculty issued by the affiliating body has not submitted by the institution.

ii. The institution has not appointed Fine Arts & Performing Arts faculty.

iii. Seven Lecturers does not have NET/Ph.D. as per NCTE (Recognition Norms & Procedure) (Amendment) Regulations, 2017 dated 29.05.2017 notified on 09.06.2017.

Hence, the Committee decided to withdraw the recognition granted to Thandrapaparaya College of Education, Near Railway Gate, JKR Buildings, Bobbili-535558, Vizianagaram District, Andhra Pradesh for conducting B.Ed, courses w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

- 6. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Thandrapaparaya College of Education, Near Railway Gate, JKR Buildings, Bobbili-535558, Vizianagaram District, Andhra Pradesh run by Sri Lokabandu Educational Society, Vizianagaram District, Andhra Pradesh for conducting B.Ed. course of two years duration with an annual intake of 100 students w.e.f. the next academic session.
- 7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
