WHEREAS, the recognition was granted to the institution namely St. Mary's College of Education, Sheripally Village, Devarakonda Mandal, Nalgonda District-508284, Telangana run by Joseph Sriharsha & Mary Indraja Educational Society, Hyderabad-500070, Telangana. The SRC vide order F.AP/B.Ed/SRO/NCTE/APSO2666/2005-2006/6664 dt.04.07.2006 for conducting (B.Ed.) course of two-year duration from the academic session 2005-06 with an annual intake of 100 students.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 13.10.2014. A Revised Provisional Recognition Order was issued to the institution on 20.07.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students (two units) from the academic session 2015-2016.
- 3. AND WHEREAS, the institution has submitted shifting proposal on 03.10.2007 along with DD of Rs 1,50,000/- bearing No. 006742 dated 07.09.2015 and relevant documents. The SRC in its 325th Meeting held on 17th 18th June, 2016 considered the matter and decided as under:-
 - 1. Title Deed is in order.
 - 2. Inspection fee is paid in full.
 - 3. BCC is not approved by competent authority. Also, it is in the name of the Society and not the institution.
 - 4. Original FDRs and latest faculty list are not given.
 - 5. LUC and EC are in order.
 - 6. Cause inspection for shifting. B.Ed (2 units)

As per the decision of SRC a letter was issued to the institution on 13.07.2016.

- 4. AND WHEREAS, the SRC in its 381st meeting held on 31st Oct 01st Nov 2019 considered the matter and decided to issued SCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents in response to RPRO issued by the SRC. Accordingly, a First Show Cause Notice was issued on 25.11.2019. The institution has not submitted any reply to the First Show Cause Notice till date.
- 5. AND WHEREAS, the matter was further considered by the SRC in its 392nd meeting held on December 15-16, 2020 and the Committee decided as follows: -

furnished by the institution were carefully considered by the SRC and the following observations were made:-

1. The management has not shifted its institution to its own permanent building which is in violation of the NCTE Regulations, 2002, 3(C).

2. The institution has also not responded to the Show Cause Notice issued on 25.11.2019.

Hence, the Committee decided to withdraw the recognition granted to St. Mary's College of Education, Sheripally Village, Devarakonda Mandal, Nalgonda District-508284, Telangana for conducting B.Ed course w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

- 6. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to St. Mary's College of Education, Sheripally Village, Devarakonda Mandal, Nalgonda District-508284, Telangana run Joseph Sriharsha & Mary Indraja Educational Society, Hyderabad-500070, Telangana for conducting B.Ed. course of two years duration with an annual intake of 100 students w.e.f. the next academic session.
- 7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
