AND WHEREAS, the recognition was granted to the institution namely Sri Vivekananda College of Education, No. 1-7-19/1, Narsapet Road, Mahaboobnagar, Warangal District -506101, Telangana run by Prabhu Educational Society, Mahaboobnagar, Warangala District - 506101, Telangana. The SRC vide order F.SRO/NCTE/APSO3700/B.Ed/2005dt.16.01.2006 for conducting (B.Ed.) course of two-year duration from the 2006/5172 academic session 2005-06 with an annual intake of 100 students.

- AND WHEREAS, or promulgation of NCTE Regulations, 2014, the institution by 2. consented to come under new Regulations vide a notarized affidavit dated 21.01.2015. A Revised Provisional Recognition Order was issued to the institution on 11.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students (two units) from the academic session 2015-2016.
- AND WHEREAS, the SRC in its 342nd meeting decided for reduction of intake from 2 units to 1 unit. Accordingly, an order dated 21.7.2017 was issued.
- AND WHEREAS, the matter was placed before the Sothern Regional Committee in its 369th meeting held on 28.01.2019. The Committee decided to issue show cause notice to all such institutions which have not submitted compliance of the revised recognition order. Accordingly, as per the decision of SRC show cause notice was issued to the institution on 18.03.2019. The institution vide letter dated 15.04.2019 submitted its reply to the show cause notice.
- AND WHEREAS, the SRC in its 381st meeting held on 31st Oct 01st Nov 2019 considered the matter and decided to issued SCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents in response to RPRO issued by the SRC. Accordingly, a Final Show Cause Notice was issued on 21.11.2019. The institution has not submitted any reply to the Final Show Cause Notice till date.
- AND WHEREAS, the matter was further considered by the SRC in its 392nd meeting held on December 15-16, 2020 and the Committee decided as follows: -

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

1. The management has not shifted its institution to its own permanent building which is in violation of the NCTE Regulations, 2002, 3(C).

2. The institution has also not responded to the Final Show Cause Notice issued on 21.11.2019.

Hence, the Committee decided to withdraw the recognition granted to Sri Vivekananda College of Education, No. 1-7-19/1, Narsapet Road, Mahaboobnagar, Warangal District — 506101, Telangana for conducting B.Ed course w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

- 7. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Sri Vivekananda College of Education, No. 1-7-19/1, Narsapet Road, Mahaboobnagar, Warangal District 506101, Telangana run by Sri Vivekananda College of Education, No. 1-7-19/1, Narsapet Road, Mahaboobnagar, Warangal District 506101, Telangana for conducting B.Ed. course of two years duration with an annual intake of 100 students w.e.f. the next academic session.
- 8. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
