ORDER

WHEREAS, recognition was granted to the institution namely St. John's College of Education, Agape Centre, Chengicherla Village, Boduppal Post, Ghatkesar Mandal, Rangareddy District-500039, Andhra Pradesh run by Christian Outreach Uplifted New Rangareddy District, Andhra Pradesh vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed/2006-2007/2191 dt. 01.05.2007 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 23.02.2015 for its willingness for adherence of provisions of new Regulations. A Revised Provisional Recognition order was issued to the institution on 06.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 50 (One basic unit) from the academic session 2015-16.
- AND WHEREAS, the SRC in its 368th meeting held during 08th 09th January, 2019 considered the matter and decided to issue SCN. Accordingly, as per the decision of SRC a show cause notice was issued to the institution on 17.01.2019. The institution did not reply to the show cause notice till date.
- AND WHEREAS, the Sub-Committee of the SRC in 380th meeting decided to issue Final Show Cause Notice to all such institution where reply to SCN has not been submitted by the institution. Accordingly, a Final Show Cause Notice was issued to the institution on 11.10.2019. The institution vide letter dated 23.10.2019 submitted its reply to the final show cause. The SRC in its 382nd meeting held on 26th - 27th November, 2019 considered the matter and decided to issue withdrawal order. Accordingly, a withdrawal order was issued to the institution vide order no. F/SRO/NCTE/APSO7057/B.Ed/TS/2019/113042-3048 dt. 10.12.2019.
- AND WHEREAS, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order dated 04.11.2020 appeal remand back the Order appealed against. The institution vide letter received on 18.11.2020 submitted reply to the alongwith land & building documents having address as Sy.No. 17, Agape Centre Phase-III, Chengicherla Village, Medipally (Mandal), Boduppal (Post), Medchal Malakjiri District-500039, Telangana and staff list etc.
- AND WHEREAS, the SRC in its 392nd meeting held on 15th 16th December, 2020 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply submitted by the institution, the Committee decided that the continuation order be issued to the Institution St. John's College of Education, Agape Centre, Chengicherla Village, Boduppal Post, Ghatkesar Mandal, Rangareddy District-500039, Telangana for B.Ed programme for 1 basic unit of 50 students.

- 7. NOW THEREFORE, this order is issued permitting the institution i.e. St. John's College of Education, Sy.No. 17, Agape Centre Phase-III, Chengicherla Village, Medipally (Mandal), Boduppal (Post), Medchal Malakjiri District-500039, Telangana run by Christian Outreach Uplifted New Tribes, Agape Centre Phase-III, Chengicherla Village, Medipally (Mandal), Boduppal (Post), Medchal Malakjiri District-500039, Telangana for continuation of recognition for B.Ed course of two years duration with an intake of 50 students (1 basic unit) of subject to fulfillment of the following conditions:-
 - I.The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II.The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 8. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 9. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 10. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:

- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 11. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 12. The institution shall make available the list of students admitted on its official website.
- 13. The institution shall fill the information on GIS Portal on the NCTE Website.
