**WITHDRAWAL ORDER**

**WHEREAS**, the recognition was granted to the institution namely **Williams College of Education, No.1-379, APSP Post, Teacher's Colony, Rayudupalem Kakinada-533005, East Godavari District, Andhra Pradesh** run by **Christian Outreach Center, East Godavari District, Andhra Pradesh** vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed/2007-2008/13321 dt 23.10.2007 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

**AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt. 27.01.2015 for its willingness for adherence of provisions of new Regulations.

**AND WHEREAS**, a revised provisional recognition order was issued to the institution on 06.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.

**AND WHEREAS**, the institution submitted written representation on **26.04.2016** requesting for reduction of strength from 2 units to 1 unit in its B.Ed. course. Accordingly, order for reduction of strength from 2 units to 1 unit issued on 21.07.2017.

**AND WHEREAS**, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, Show Cause Notice was issued to the institution on 13.05.2019.

**AND WHEREAS**, the SRC in its 381st meeting held on 31st Oct & 01st, Nov, 2019 considered the matter and decided to issue Final SCN u/s 17 of the NCTE Act issued to the institution to submit its representation/reply to the observation noted by the Regional Committee. Accordingly, a Final Show Cause Notice was issued to the institution on 13.11.2019. The institution submitted its reply on 27.02.2020 to the Final Show Cause Notice.

**AND WHEREAS**, the SRC in its 392<sup>nd</sup> Meeting held on 15<sup>th</sup> & 16<sup>th</sup> December, 2020 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee noted the reply submitted by the institution on 27.02.2020 in respect to the Final Show Cause Notice, and the Committee made following observations: -

1. The institution has submitted notarized copy of LUC but Diverted area and Purpose of LUC not mentioned.
2. The institution has submitted Notarized copy of building plan but survey No. not mentioned.  
(i) Area of Multipurpose Hall not sufficient as per NCTE norms.
3. The institution has not submitted a Letter regarding approval of faculty issued by the affiliating body.  
(i) Faculty in Performing Arts is not appointed.

4. The institution has submitted Form "A" issued by the Branch Manager Rs.500000/-with the photocopy of two Matured FDRs Rs.300000/- and 500000/-

- (i) The institution is required to submit a "Form A" issued by the respective Bank Manger towards creation of FDR of Rs.7 lakh and 5 lakh, totalling Rs.12 lakh towards Endowment Fund & Reserve Fund into joint account for a duration of 5 years along with a copy of the FDRs.

Hence, the Committee decided to withdraw the recognition granted to **Williams College of Education, No.1-379, APSP Post, Teacher's Colony, Rayudupalem Kakinada-533005, East Godavari District, Andhra Pradesh** for conducting B.Ed, courses w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

**NOW, THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of **Williams College of Education, No.1-379, APSP Post, Teacher's Colony, Rayudupalem Kakinada-533005, East Godavari District, Andhra Pradesh** for conducting B.Ed. programme of two year duration with an annual intake of 50 students (1 unit) w.e.f. the next academic session.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

**"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day falls or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."**

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
