**CONTINUATION ORDER**

WHEREAS, the recognition was granted to the institution namely **Bapuji College of Physical Education, BIET Campus, Davanagere, Karnataka-577004** vide SRC (NCTE) order F.SRO/NCTE/B.P.Ed./2005-2006/3375 dated 10.10.2005 for **B.P.Ed. Course** of one-year duration from the academic session 2005-2006 with an annual intake of 50 students.

2. **AND WHEREAS**, vide order no. F.SRO/NCTE/APS02155/B.P.Ed./KA/2013-14/55409 dt. 13.12.2013 recognition accorded to **Bapuji Education Society Bapuji College of Physical Education, BIET Campus, Davangere, Karnataka-577004** for B.P.Ed. course with annual intake of 50 students was withdrawn with effect from the academic session 2014-2015.

3. **AND WHEREAS**, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. 89-60/2014 Appeal/6<sup>th</sup> Meeting-2014 dated 29.05.2014 appeal remand back the order.

4. **AND WHEREAS**, vide order no. F.SRO/NCTE/APS02155/B.P.Ed./KA/2014-2015/61413 dt. 30.01.2015 recognition accorded to the **Bapuji College of Physical Education, S.S. Layout, 'A' Block, Lake View Campus, Davangere, Karnataka 577004 B.P.Ed. Programme** was restored/continued till further order also permission to shift from **B.I.E.T. Campus, Davangere, Karnataka** to **S.S. Layout 'A' Block, Lake View Campus, Davangere, Karnataka-577004**.

5. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution had submitted affidavit dated 01.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 31.03.2015 for conducting B.P.Ed. Programme of two years duration with an annual intake of 100 (two sections of 50 students each) from the academic session 2015-16.

6. **AND WHEREAS**, the SRC in its 375<sup>th</sup> Meeting held on 28.01.2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted compliance of the revised recognition order. Accordingly, as per decision of SRC a Show Cause Notice was issued to the institution on 16.05.2019. The institution did not submit reply to the Show Cause Notice.

7. **AND WHEREAS**, the SRC in its 388<sup>th</sup> meeting held on 14<sup>th</sup>-15<sup>th</sup> September 2020 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC a Final Show Cause Notice was issued to the institution on 09.10.2020. The institution has submitted reply on 05.10.2020.

8. **AND WHEREAS**, the SRC in its 402<sup>nd</sup> meeting held on 13<sup>th</sup> & 14<sup>th</sup> December, 2021 has considered the matter and decided to withdraw the recognition. Accordingly, as per the decision of SRC, a Withdrawal Order No. F.SRO/NCTE/APS02155/B.P.Ed./KA/2021/128729 dated 06.10.2021 was issued to the institution.



9. **AND WHEREAS**, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. 89-325/E-230632/2022 Appeal/1<sup>ST</sup> Meeting, 2022 Appeal No. APPLSRC202114202 dated 31.01.2022 appeal remand back the order. The institution has submitted reply on 02.02.2022.

10. **AND WHEREAS**, the SRC in its 407<sup>th</sup> meeting held on 15<sup>th</sup> February, 2022 considered the matter and decided as under:-

*"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-*

*The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution **Bapuji College of Physical Education, Survey No. 90/1A/90/1B, Lake View Campus, S.S Layout, 'A' Block, Davanagere-577004, Karnataka for B.P.Ed. programme for 1 basic unit of 100 students.**"*

11. **NOW THEREFORE**, this order is issued permitting the institution i.e. **Bapuji College of Physical Education, Survey No. 90/1A/90/1B, Lake View Campus, S.S Layout, 'A' Block, Davanagere-577004, Karnataka run by Bapuji Educational Association, S.S. Layout 'A' Block, Lake View Campus, Davangere, Karnataka-577004** for continuation of recognition for **B.P.Ed. Programme for two years duration with an annual intake of 1 basic unit of 100 students** subject to fulfilment of the following conditions:-

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

12. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

13. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

14. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left or joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

**15.** The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

**16.** The institution shall make available the list of students admitted on its official website.

**17.** The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
