### **ORDER**

WHEREAS, the recognition was granted to the institution namely, Tagore Government College of Education, M.G. Road, Middle Point, Port Blair-744101, Andaman & Nicobar Islands run by Pondicherry University vide SRC (NCTE) order No. F.NO.A&N/SEC/A1/01/SRC/NCTE/2005-2006/604 dated 08.07.2005 for conducting B.Sc.B.Ed. (Mathematics) Integrated course of four-year duration with an annual intake of 20 students from the academic session 2005-2006.

- 2. AND WHEREAS, a continuation order was issued to the institution on 11.06.2019 for conducting B.Sc.B.Ed. course of four years duration with an annual intake of 50 students (one basic unit) from the academic session 2019-2020.
- 3. AND WHEREAS, a letter copy to dated 19<sup>th</sup> march, 2021 received from the Principal Tagore Government College of Education, Andaman and Nicobar Administration regarding reservation for the student of Economically Weaker Section (EWS) for admission to various Courses in the Teacher Education Institution (TEIs) and issue of formal orders.
- **4. AND WHEREAS,** the matter was further considered by the SRC in its 398<sup>th</sup> meeting held on 07<sup>th</sup> April, 2021 and the Committee decided as under.

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:

The matter pertaining to TAGORE GOVERNMENT COLLEGE OF EDUATION, Port Blair, M.G. Road, Middle Point, Andaman & Nicobar Island-744101 which was deferred in the last meeting discussed in detail in the light of clarification given by the Member Secretary, NCTE Hq. vide his letter No. Regl011/19/2019-US(Regulation) – HQ dated 08.07.2019. As directed by the NCTE Hqrs. the Committee decided to ratify the action taken by the Govt. of Andaman & Nicobar Island in creation of additional 10% seats as a special case under EWS reservation. The same is also approved by the Pondicherry University which is the affiliating University.

In the circumstances stated the Committee ratified the increase of 10% seats in each of the NCTE approved existing teacher education programme run by the institution. The same may be informed to the institution and affiliating body accordingly."

5. NOW THEREFORE, this order is issued permitting the institution continuation of conducting Tagore Government College of Education, M.G. Road, Middle Point, Port Blair-744101, Andaman & Nicobar Islands run by Pondicherry University for B.Sc.B.Ed. course of four years duration with an intake of 50(50+5=55) students subject to fulfillment of the following conditions:

The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.

The institution shall comply with the various other norms and standards prescribed in 11.

the NCTE Regulations, 2014 as amended from time to time.

The institution shall make admissions only after it obtains affiliation from the examining III. body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014

- The institution shall ensure that the required number of academic staff duly approved by IV. affiliating body for conducting the course should always remain in position.
- Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.
- The institution shall submit to the Regional Committee as Self Appraisal Report at the 7. end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter - alia, the details of the institution, its locations, name of the programme (s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
  - a. Sanctioned programme(s) along with annual intake in the institution:
  - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c. Name of faculty members who left of joined during the last, quarter:
  - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
  - e. Fee charged from students;
  - f. Available infrastructural facilities;
  - g. Facilities added during the last quarter;
  - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;

  - i. The affidavit with enclosure submitted along with application.j. The institution shall be free to post additional relevant information, if it so desires.
  - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- The institution shall make available the list of students admitted on its official website. 10.
- The institution shall fill the information on GIS Portal on the NCTE Website. If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and

orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
