CONTINUATION ORDER

WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely **Kunjukrishnan Nadar Memorial B.Ed. College, Kunjiramkulam P.O Neyyattinkara, Kerala - 695524** vide SRC (NCTE) order no. F.KL/SEC/N/214/SRO/NCTE/2005-2006/4009 dt. 16.11.2005 for Secondary course of one year duration from the academic session 2005-2006 with an annual intake of 100 students.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. nil for its willingness and adherence of provisions of new Regulations. Thereafter, a revised provisional recognition order was issued to the institution on 15.05.2015 for conducting **B.Ed. course of two years duration with an annual intake of 50 students (one basic unit) from the academic session 2015-16.**


3. **AND WHEREAS**, the SRC in its 369th meeting held on 28th January 2019 considered the matter and decided to issue a Show Cause Notice to all such institutions which have not submitted compliance. Accordingly, as per decision of SRC, a Show Cause Notice has been issued to the institution on 17.07.2019. The institution did not submit reply to Show Cause Notice.

4. **AND WHEREAS**, the matter was further considered by the Sub-Committee constituted by the SRC as per its decision taken in 380th meeting held on 18th-19th September 2019. The Sub-Committee of the SRC decided to issue Final Show Cause Notice to all such institution where reply to SCN has not been submitted by the institution. Accordingly, as per decision of SRC, a Final Show Cause Notice has been issued to the institution on 31.10.2019. The institution did not submit reply to Final Show Cause Notice.

5. **AND WHEREAS**, the SRC in its 389th meeting held on 12th & 14th October 2020 considered the matter and decided to withdraw the recognition. Accordingly, as per decision of SRC, a Withdrawal Order vide order no. F.SRO/NCTE/APSO0796/B.Ed./{KL}/2020/119657-9663 was issued to the institution on 19.10.2020.

6. **AND WHEREAS**, the institution has filed the writ petition W.P. No. 24534/2020 before the Hon'ble High Court of Kerala at Ernakulam. A letter has been issued to the Standing Counsel, Shri Abraham P. Meachinkara to defend the case on behalf of NCTE and apprise the Hon'ble Court on 24.11.2020.

7. **AND WHEREAS**, the Judgment has been passed by the Hon'ble High Court of Kerala at Ernakulam on 15.09.2021. The SRC in its 404th Meeting held on 16th & 17th November, 2021 has considered the matter and decided to issued a letter. Accordingly, as per the decision of SRC a letter was issued to the institution on 09.12.2021. The institution has submitted its reply vide letter dt. 01.12.2022.

8. **AND WHEREAS**, the SRC in its 421st Meeting held on 10th February, 2023 has considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 20.02.2023. The institution has submitted its reply vide letter dated 28.02.2023.

9. **AND WHEREAS**, the SRC in its 423rd meeting held on 12th April, 2023 considered the matter and Committee decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Kunjukrishnan Nadar Memorial B.Ed. College, Survey No. 363/8, 363/2, 363/2-3 & 363/2-4, Village Kanjiramkulam, Kanjiramkulam P.O. Neyyattinkara-695524, Kerala for B.Ed. programme for 1 basic unit of 50 students."

10. **NOW THEREFORE**, this order is issued permitting the institution i.e. Kunjukrishnan Nadar Memorial B.Ed. College, Survey No. 363/8, 363/2, 363/2-3 & 363/2-4, Village Kanjiramkulam, Kanjiramkulam P.O. Neyyattinkara-695524, Kerala for continuation of recognition for B.Ed. Programme of two years duration with an annual intake of (1 basic unit) of 50 students subject to fulfilment of the following conditions:-

I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.

II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.

III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.

IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

11. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

12. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

13. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the



programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.


14. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

15. The institution shall make available the list of students admitted on its official website.

16. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
