WHEREAS, the recognition was granted to the institution namely Centre for Research on New International Econoic Order (Crenieo)'s Dr. Kunchala Rajarathnam Chritian College of Education, K.L.I.M. Hospital, Jeevagram, Renigunta, Chittoor Dt., Andhra Pradesh run by Centre for Research on New International Economic Order, Dr. Kunchala Rajarathnam College of Education, K.L.I.M. Hospital, Jeevagram, Renigunta-571520, Chittoor District, Andhra Pradesh. The SRC vide order F.AP/SEC/NEW/278/SRO/NCTE/2002-2003/7392 dt. 14.05.2003 for conducting (B.Ed.) course of two-year duration from the academic session 2002-03 with an annual intake of 100 students.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 08.01.2015. A Revised Provisional Recognition Order was issued to the institution on 12.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students (two units) from the academic session 2015-2016.
- 3. AND WHEREAS, the SRC in its 381st meeting held on 31st Oct & 01st Nov 2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents in response to RPRO issued by the SRC. Further the Committee also suggested on receiving the reply to the SCN, the SRO may scrutinize the documents and still if there are some deficiency/lapses, the RD is authorized to issue First SCN and then place the cases before the SRC for its perusal and decision. Accordingly, a First Show Cause Notice was issued to the institution on 20.11.2019
- 4. AND WHEREAS, the institution has not submitted any reply in response to the First Show Cause Notice till date.
- 5. **AND WHEREAS**, the SRC in its 392nd meeting held on 15th 16th December 2020. The Committee considered the matter and decided as under: -

"The Committee noted that the institution has failed to submit reply / written representation in respect to the Show Cause Notice dt 20.11.2020 issued to the institution. And also in view of the letter received No. RC.No. 359/A/SCERT/2019 dated 29.6.2020 is received from the Commissioner, School Education (FAC), School Education Department, Govt. of Andhra Pradesh on 17.07.2020.

Hence, the Committee decided to withdraw the recognition granted to Sree Rama

6. AND WHEREAS, the matter was further considered by the SRC in its 393^{rd} meeting held on January $5^{th} - 6^{th}$, 2021 and the Committee decided as follows: -

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

"The Committee noted that the institution has failed to submit reply / written representation in respect to the Show Cause Notice dt 20.11.2020 issued to the institution. And also in view of the letter received No. RC.No. 359/A/SCERT/2019 dated 29.6.2020 is received from the Commissioner, School Education (FAC), School Education Department, Govt. of Andhra Pradesh on 17.07.2020.

Hence, the Committee decided to withdraw the recognition granted to Centre for Research on New International Econoic Order (Crenieo)'s Dr. Kunchala Rajarathnam Chritian College of Education, K.LL.M. Hospital, Jeevagram, Renigunta, Chittoor Dt., Andhra Pradesh for conducting B.Ed course w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above".

- 7. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Centre for Research on New International Econoic Order (Crenieo)'s Dr. Kunchala Rajarathnam Chritian College of Education, K.LL.M. Hospital, Jeevagram, Renigunta, Chittoor Dt., Andhra Pradesh run by Centre for Research on New International Economic Order, Dr. Kunchala Rajarathnam College of Education, K.L.L.M. Hospital, Jeevagram, Renigunta-571520, Chittoor District, Andhra Pradesh for conducting B.Ed. course of two years duration with an annual intake of 100 students w.e.f. the next academic session.
- **8.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education

immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
