ORDER

WHEREAS, the recognition was granted to the institution namely **Al-Momin College of Education, Kandukur Revenue Division 3/17, East Palem, Podili, Prakasam District-523240, Andhra Pradesh** vide SRC (NCTE) order no. F.AP/SEC/NEW/267/SRO/NCTE/2002-2003/7966 dt. 03.07.2003 (P-446/Coors.) for conducting B.Ed. course of one year duration with an annual intake of 100 students from the academic session 2002-2003.

2. **AND WHEREAS**, the SRC in its 176<sup>th</sup> meeting held on 27<sup>th</sup> – 28<sup>th</sup> May, 2009 considered the matter and decided to issue withdraw order. Accordingly, as per the decision of SRC withdrawal order was issued to the institution on 25.06.2009.

3. **AND WHEREAS**, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. F.No.89-738/2009-Appeal dated 08.10.2009 and the Council remands back the case.

4. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dated 21.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 15.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.

5. **AND WHEREAS**, the SRC in its 369<sup>th</sup> meeting held on 28.01.2019 considered the matter and decided that show cause notice be issued to all such institutions which have not submitted compliance of conditions stipulated in RPRO. Accordingly, as per the decision of SRC a show cause notice was issued to the institution on 05.02.2019. The institution vide letter dated 19.02.2019 submitted reply to the show cause notice. The SRC in its 374<sup>th</sup> meeting held on 09<sup>th</sup> – 10<sup>th</sup> April, 2019 considered the matter and decided to issue Show Cause Notice. Accordingly, as per the decision of SRC a show cause notice was issued to the institution on 22.04.2019. The institution vide letter dated 17.12.2019 submitted reply to the show cause notice.

6. **AND WHEREAS**, the SRC in its 384<sup>th</sup> meeting held on 12<sup>th</sup> – 13<sup>th</sup> February, 2020 considered the matter and decided to constitute VT. Accordingly, as per the direction of the SRC the inspection was conducted on 17<sup>th</sup> & 18<sup>th</sup> December, 2020 and the VT Report received in this office on 22.12.2020.

7. **AND WHEREAS**, the SRC in its 393<sup>rd</sup> meeting held on 05<sup>th</sup> – 06<sup>th</sup> January, 2021 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by

the institution were carefully considered by the SRC and the following observations were made:-

The Committee on the perusal of the reply submitted by the institution; the Committee decided that the continuation order be issued to the Institution **Al-Momin College of Education, Kandukur Revenue Division 3/17, East Palem, Podili, Prakasam District-523240, Andhra Pradesh** for B.Ed programme for 2 basic units of (50 students each unit). In addition to the above, the **Shifting of premises of the institution to its own new permanent building is also hereby permitted.**

8. **NOW THEREFORE**, this order is issued permitting the institution i.e. Al-Momin College of Education, East Palem, Podili, Prakasam District – 523240, Andhra Pradesh to shift its building at new address at Survey No. 1113/D, 20<sup>th</sup> ward, Rajupalem Road, Podili Panchayat, Podili (V), Podili Mandal, Prakasam District- 523240, Andhra Pradesh run by Al-Momin Foundation Iqra Education Society, Raju Palamu Road, Podili Taluka Mandal, Prakasam District- 523240, Andhra Pradesh Further as per the decision of the SRC, an order for continuation of recognition for B.Ed course of two years duration with an intake of 100 students (two units) of 50 students each subject to fulfilment of the following conditions:-

I.The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.

II.The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.

III.The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.

IV.The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

9. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

10. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.


11. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with

photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution:
  - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c. Name of faculty members who left of joined during the last, quarter:
  - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
  - e. Fee charged from students;
  - f. Available infrastructural facilities;
  - g. Facilities added during the last quarter;
  - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
  - i. The affidavit with enclosure submitted along with application.
  - j. The institution shall be free to post additional relevant information, if it so desires.
  - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
12. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
13. The institution shall make available the list of students admitted on its official website.
14. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
