ORDER

WHEREAS, the recognition was granted to the institution namely Kingston College of SRC (NCTE) Pradesh vide Andhra District. Medak Education, F.AP/NEW/B.Ed/286/SRO/NCTE/2002-2003/6670 dated 08.04.2003 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution submitted 2. affidavit dt. 22.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 11.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.
- AND WHEREAS, the SRC issued a Corrigendum vide Order No. F.SRO/NCTE /APS00320/B.Ed/AP/2015/69049 to the institution on 01.07.2015 one basic unit.
- AND WHEREAS, the institution VT conducted on 18.08.2016 and the VT report was received in the office on 29.08.2016 along with documents. The SRC in its 321st meeting held on 28th - 29th September 2016 considered the VT report and decided to issue Show Cause Notice. Accordingly, as per the decision of SRC Show Cause Notice was issued to the institution on 26.10.2016.
- AND WHEREAS, the SRC in its 381st meeting held on 31st Oct 01st Nov 2019 considered the matter and decided to issued SCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents in response to RPRO issued by the SRC. Accordingly, a First Show Cause Notice was issued on 19.11,2019. The institution has not submitted any reply to the First Show Cause Notice till date.
- AND WHEREAS, the SRC in its 392nd meeting held on 15th 16th December 2020 has 6. considered the matter and decided to Withdrawal order. Accordingly, as per the decision of SRC withdrawal order was issued to the institution on 18.12.2020. The institution vide letter dated 28.12.2020 has submitted a written representation.
- AND WHEREAS, the SRC in its 393rd meeting held on 05th 06th January, 2021 7. considered the matter and decided as under:-

On the perusal of the reply submitted by the institution, the Committee decided that the continuation order be issued to the Institution Kingston College of Education, Siddipet Revenue Disvision, Ponnala village, Siddipet Mandal Medak District, Telangana for B.Ed programme for 2 basic units of 50 students each unit.

- 8. NOW THEREFORE, this order is issued permitting the institution i.e. Kingston College of Education, Sy. No. 23, Pnnala Village, Siddipet, Mandal, Medak District- 502277 Andhra Pradesh run by Kingston Educational Society, Prathapnagar, Musaram Bagh, Dilsukhnagar, Hyderabad, Telangana for continuation of recognition for B.Ed course of two years duration with an intake of 100 students (2 basic units) of subject to fulfillment of the following conditions:-
 - I.The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 9. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 10. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 11. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- Available infrastructural facilities; f.
- Facilities added during the last quarter; a.
- Number of books in the library, journals subscribed to and additions, if any, in the h. last quarter:

- The institution shall be free to post additional relevant information, if it so desires. i. j.
- Any false or incomplete information on website shall render the institution liable k. for withdrawal of recognition.
- The institution shall adhere to the mandatory disclosure in the prescribed format and 12. display up-to-date information on its official website.
- The institution shall make available the list of students admitted on its official website. 13.
- The institution shall fill the information on GIS Portal on the NCTE Website. 14.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
