WHEREAS, the recognition was granted to the institution namely Bennaiah D.Ed. College, Khasara no.673, Street no.1, Burugupudi Village and Post, Korukonda Mandal Taluk, Rajahmundry City, East Godavari District, Pin-533292, Andhra Pradesh run by VVS Christian Educational Society, Il Floor, Satya Surya Complex, Dwaraka Nagae Village, Vishakhapatnam Post and Taluk, Vishkahpatnam District, Pin-530016, Andhra Pradesh. The SRC vide order SRCAPP1179/D.El.Ed.-A dt. 24.09.2012 for conducting (D.El.Ed.) course of two-year duration from the academic session 2012-13 with an annual intake of 50 students.

- 2. AND WHEREAS, the Committee perused the letter No. RC.No. 359/A/SCERT/2019 dated 29.6.2020 received from Commissioner, School Education (FAC), School Education Department, Govt. of Andhra Pradesh recommending therein for derecognition order in respect of 188 Pvt. D.el.Ed. colleges in A.P. since the said managements of Pvt. D.El.Ed. colleges have made admission into the D.El.Ed. course during academic year 2018-19 on their own in violation of Government orders.
- 3. AND WHEREAS, the SRC in its 386<sup>th</sup> meeting held on 23<sup>rd</sup> & 24<sup>th</sup> July 2020 considered the matter and decided to issue Show Cause Notice. As per decision of SRC, a Show Cause Notice was issued to the institution on 29.09.2020. The institution has not submitted any reply in response to the Show Cause Notice till date.
- 4. AND WHEREAS, the institution has not submitted any reply in response to the First Show Cause Notice till date.
- 5. AND WHEREAS, the SRC in its 392<sup>nd</sup> meeting held on 15<sup>th</sup> 16<sup>th</sup> December 2020. The Committee considered the matter and decided as under: -

"The Committee noted that the institution has failed to submit reply /written representation in respect to the Show Cause Notice dt 29.09.2020 issued to the institution. And also in view of the letter received No. RC.No. 359/A/SCERT/2019 dated 29.6.2020 is received from the Commissioner, School Education (FAC), School Education Department, Govt. of Andhra Pradesh on 17.07.2020.

Hence, the Committee decided to withdraw the recognition granted to Narayana College of Teacher Education, Khasra No.732/2, Plot No.5-104/1, Street No.1, Gudimellanka Village, Malikipuram Post & Taluka, East Godavari District-533253, Andhra Pradesh for conducting D.El.Ed

Accordingly, a withdrawal order to be issued to the institution, but there is a typographical error in the name of the institution mentioned in the decision. The correct name & address of the institution is as "Bennaiah D.Ed. College, Khasara no.673, Street no.1, Burugupudi Village and Post, Korukonda Mandal Taluk, Rajahmundry City, East Godavari District, Pin-533292, Andhra Pradesh".

**6. AND WHEREAS,** the matter was further considered by the SRC in its  $393^{rd}$  meeting held on January  $5^{th} - 6^{th}$ , 2021 and the Committee decided as follows: -

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee noted that the institution has failed to submit reply /written representation in respect to the Show Cause Notice dt 29.09.2020 issued to the institution. And also in view of the letter received No. RC.No. 359/A/SCERT/2019 dated 29.6.2020 is received from the Commissioner, School Education (FAC), School Education Department, Govt. of Andhra Pradesh on 17.07.2020.

Hence, the Committee decided to withdraw the recognition granted to Bennaiah D.Ed. College, Khasara no.673, Street no.1, Burugupudi Village and Post, Korukonda Mandal Taluk, Rajahmundry City, East Godavari District, Pin-533292, Andhra Pradesh for conducting D.El.Ed course w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

- 7. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Bennaiah D.Ed. College, Khasara no.673, Street no.1, Burugupudi Village and Post, Korukonda Mandal Taluk, Rajahmundry City, East Godavari District, Pin-533292, Andhra Pradesh run by VVS Christian Educational Society, Il Floor, Satya Surya Complex, Dwaraka Nagae Village, Vishakhapatnam Post and Taluk, Vishkahpatnam District, Pin-530016, Andhra Pradesh for conducting B.Ed. course of two years duration with an annual intake of 50 students w.e.f. the next academic session.
- 8. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or

permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="https://www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
