Preamble:

Global College of Education, Karnataka Education Society, Sy.No.11/3-e, Bidar-Gunnalli Road, Gunnali, Bidar - 585403, Karnataka has submitted application to SRC on 30.09.2008. Inspection of the institution was carried out on 13.03.2009. The inspection report of the institution was placed before SRC in its 172nd Meeting held on 25-26 March, 2009. As the facilities created by the institution were not as per NCTE norms, a notice was issued to the institution on 16.04.2009.

Institution submitted its written representation on 30.04.2009. The SRC in its 175th Meeting held on 13-14 May, 2009 considered the written representation submitted by the institution and decided to cause re-inspection. Accordingly, re-inspection was carried out on 13.06.2009. the re-inspection report was placed before SRC in its 177th meeting held on 22-23 June 2009 and decided to refuse recognition. Accordingly, order of refusal was issued to the institution vide order dated 16.07.2009.

The institution preferred an appeal dated 13.08.2009 and the Appellate Authority vide it s order dated 06.11.2009 has reversed the orders of SRC. Accordingly, LOI was issued to the institution on 01.12.2009. The institution has submitted its written representations on 08.12.2009 and 24.12.2009 and the same was placed before SRC in its 187th meeting held on 29-30 December 2009. SRC considered the written representation and decided to issue formal recognition order.

Hence the order.

ORDER

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 Karnataka Education Society, Badruddin Colony, Chidri Road, Bidar – 585403, Karnataka has submitted an application to the Southern Regional Committee of NCTE for grant of recognition for conducting B.Ed course with an intake of 100 students on 30.09.2008.

AND WHEREAS on scrutiny of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography, institution fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the B.Ed teacher education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has appointed duly qualified teaching staff as per NCTE norms.

Now, therefore, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Southern Regional Committee hereby grants recognition to Global College of Education, Karnataka Education Society, Sy.No.11/3-e, Bidar-Gunnalli Road, Gunnali, Bidar – 585403, Karnataka for conducting B.Ed course of One year duration with an annual intake of 100 (One hundred) students from the academic session 2009-2010 under clause 7(11) of NCTE(Recognition Norms & Procedure) Regulations, 2007 subject of fulfillment of the following conditions:

- I. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- II. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE(Recognition Norms & Procedure) Regulations, 2007.
- III. The institution shall ensure that the required number of academic staff for conducting the course is always in position.
- 4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, as applicable.
- 5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.
- 6. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-
 - (i) Copy of the Application Form
 - (ii) Land and Building Particulars
 - (iii) Staff Profile
 - (iv) Recognition letter
 - (v) Information for having fulfilled the norms & standard and other required conditions.
- 7. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
